EP.23.078 2022-2023 Annual Report of the Senate Committee on Educational Policy

This report summarizes the activities of the Senate Committee on Educational Policy (EP) during the 2022-2023 academic year. EP met on August 29, September 12, September 26, October 3, October 24, November 7, November 28, January 23, January 30, February 20, February 27, March 20, March 27, April 10, and April 17.

In accordance with the Senate *Bylaws*, Part A, Legislative Jurisdiction, in Fulfilling the Senate's legislative jurisdiction (*Statutes*, Article II, Sections 1.b, c, and e), the Committee on Educational Policy shall work to address all matters that come before it for review, recognizing that some educational policy matters require approval beyond the campus, and that implementation of said matters may not occur until final approval has been granted. The Committee shall make recommendations to the Senate pursuant to its statutory duties, respecting the jurisdiction given to the colleges (provided in *Statutes*, Article III, Section 2c).

EP operates with three subcommittees, which take leadership of consideration of proposals referred to the Committee by the Office of the Provost. Each committee member serves on at least one of the subcommittees. All proposals which come to the Senate have been considered and voted as approved by the entire committee.

EP considered 77 new proposals, 91 administrative approvals, five reports of temporary suspensions of admission, and six reports of changes to non-direct admission.
