SC.24.07 Report on the July 20, 2023 Meeting of the Board of Trustees of the University of Illinois System in Urbana

Chairman Don Edwards called the meeting to order and began with a vocal performance of State Song: Illinois by Asia Felton.

President Tim Killeen introduced guests and observers and welcomed Chancellor Marie Lynn Miranda to her first meeting of the board. President Killeen mentioned the finalized Illinois state budget of 697.8 million- a 7% increase in operational funding for the Illinois System, and an 16.6% increase in the Monetary Award Program (MAP) funding is a sign of a trend of state financial support. The system is celebrating a record enrollment this past year of 94,800, with more than 24,000 students matriculating. 80% of the students are Illinois residents and 25,000 are underrepresented minority students. President Killeen shared system commitment to students enrolled in the system in the wake of the Supreme Court decision on affirmative action admissions. President Killeen highlighted the DPI and collaborative partnerships in Latin America and Germany, and the volume of the impactful research completed across the system.

Chair Edwards invited Chancellor Marie Lynn Miranda to provide some comments.

Chancellor Marie Lynn Miranda thanked stakeholders for the warm welcome to UIC and provided an update on the College of Dentistry from Chicago, and the Creative Writing department. Chancellor Miranda closed their remarks by committing to providing access to UIC students while following the law in the shadow of the Supreme Court decision on affirmative action.

Professor Sandra DeGroote, USC, shared the 2022-2023 University Senates Conference Annual Report.

Chair Edwards thanked Professor Sandra DeGroote for their service as Chair of USC this past academic year.

The four Board Committee reports provided background to various items on the action agenda for today.

President Killeen closed with final comments highlighting the powerful new leadership that has been approved by the Board of Trustees. President Killeen ended by recognizing the closure of the University of Illinois College of Medicine at Urbana-Champaign and celebrated the legacy of the college.

Chair Edwards again welcomed Chancellor Marie Lynn Miranda. Chair Edwards closed his remarks by emphasizing the Board of Trustees is committed to the law and supporting access and diversity in the Illinois System. Chair Edwards noted that the system is in alignment with the state of Illinois and its elected officials.
