BRIEF DESCRIPTION: The Department of Industrial and Enterprise Systems Engineering (ISE) wishes to terminate the Master of Science in General Engineering Degree program.

JUSTIFICATION: In 2006, Industrial and Enterprise Systems Engineering started two new degree programs, the MS and PhD in Systems and Entrepreneurial Engineering. It was stated in the proposal that the MS in General Engineering would be dropped after all the students enrolled in the program at the time finished. There is currently one student enrolled in the degree program. He is expected to graduate in May 2012.
