

## Proposal to the Senate Educational Policy Committee-revised April 22, 2014

## **PROPOSAL TITLE:**

Changing the minimum credit hours required for the Graduate Concentration in Human Resource Development from 24 to 12 credit hours, and reducing the minimum number of credit hours for the Ed.M. in Human Resource Education/Human Resource Development Concentration.

## **BRIEF DESCRIPTION:**

The major in Human Resource Education (HRE) currently requires a minimum of 36 credit hours for the Ed.M. degree. A graduate concentration is required for the HRE major. With the reduction in hours for the concentration, the minimum number of credit hours for the Ed.M. degree in Human Resource Education, Human Resource Development Concentration, should be reduced to 32 credit hours. This will align the minimum credit hour requirements for Ed.M. degree in HRE with other master's degrees in the Department and the College.

In addition, the proposal requests that the number of required hours for the Graduate Concentration in Human Resource Development (HRD) be reduced from 24 to 12 hours of graduate credit. In addition, the concentration will be available for all HRE degrees.

Upon approval of the proposed Education Policy, Organization and Leadership major (EP14.43) this graduate concentration will continue to be offered under the re-designated major with these revised requirements. This concentration will be available in the Ed.M., MA, C.A.S, and PhD degrees in the proposed major. In addition this concentration will be available online in the Ed.M. degree.

## **JUSTIFICATION:**

The reduction of credit hour requirements enables greater flexibility in course scheduling and increases efficiencies in instructor assignment. It further aligns the minimum number of hours for the HRD EdM with those for most other EPOL and, indeed, College of Education EdM degrees.

The following courses will be required for students declaring the Graduate Concentration in Human Resource Development:

- HRD 400: Principles of HRE (4 cr.) Or HRD 440: Work Analysis (4 cr.)
- HRD 411: Training System Design (4 cr.) Or HRD 472, Learning Technologies (4 cr.)
- HRD 530: Organization Development (4 cr.) OR HRD 540: Learning on the Job (4 cr.)

Students may earn the concentration twice if they pursue it within different degree programs and take different courses. For example, a student may earn the concentration during their Ed.M. program by taking HRD 400, 411 and 530, and then earn the concentration again during their Ph.D. program by taking HRD 440, 472 and 540.

The Appendix contains comparisons of the current and proposed degree requirements for the Ed.M. and M.S. degrees and the minimum requirements for the C.A.S and Ph.D. degrees in HRE with and without the HRD concentration.

Students currently in the HRD concentration will be given the choice to continue under the former concentration requirements until graduation or switch to the new requirements.

## **BUDGETARY AND STAFF IMPLICATIONS:**

a. Additional staff and dollars needed

The proposed changes should not result in the need for additional staff members and may actually decrease since only one-half as many courses are required. Capacity for instruction and anticipated enrollment in this concentration will remain unchanged.

b. Internal reallocations (e.g., change in class size, teaching loads, student-faculty ratio, etc.)

There is no anticipated need for reallocations as a result of this proposal.

c. Effect on course enrollment in other units and explanations of discussions with representatives of those departments

There is no anticipated effect on course enrollment in other units.
