

Proposal to the Senate Educational Policy Committee

PROPOSAL TITLE: Revisions to Graduate Minor in Balkan Studies in the Russian, East European, and Eurasian Center (REEEC) in the College of Liberal Arts and Sciences

BRIEF DESCRIPTION: The Graduate Minor in Balkan Studies is designed to accompany work in a regular discipline. It is intended for students with the baccalaureate degree who are enrolled in disciplinary M.A. or Ph.D. programs at the University of Illinois and who wish, at the same time, to develop systematic, interdisciplinary knowledge of the Balkans. The minor's purpose is to document a student's interdisciplinary engagement with the area as well as enough language study to be able to work in the region.

As a result of the changes to the Policy on Graduate Minors, we are requesting revisions to our minor in Balkan Studies. First we wish to reduce the number of hours required to earn the minor from 20 to 12. In addition we wish to allow one additional option to the required core course.

JUSTIFICATION:

We are requesting a reduction in the number of hours required for the minor because we find that our minor is very far from the norm on campus of 12 hours, and we feel that this has influenced our ability to formally enroll students in the graduate minor. The minor was first approved in 2006, and although we have had several students participate informally, we have never had a student formally complete the minor. The requirement of 12 hours without any overlap with major degree requirements is still substantial, but will not require other departments to support students for more than a single semester of additional coursework as the 20 hour requirement did.

For this minor, students may take as few as one (REES 550) or no courses within REEEC; the majority of the course work will be taken in other departments, which creates the multidisciplinary aspect of the minor. Courses that count toward the minor, however, are usually taught by REEEC-affiliated faculty in various departments across campus.

Other aspects of the program are not changing. There are no prerequisites for the graduate minor. At this time the Center does not foresee a need to limit enrollment in the minor and the small

uptick in enrollment in the required courses will be beneficial. The department has an admissions application form that can be completed by any student enrolled in a Grad College master's or doctoral program. The form requires the pertinent signatures. The REEEC Office Support Associate will continue to monitor the admission process for the minor. The Center director serves as the director of graduate studies and adviser for the M.A. program. This individual will also serve as adviser for students in the Balkan Studies minor. As with the current M.A. degree and undergraduate major and minor, the Associate Director will be responsible for certifying that the requirements for the graduate minor in Balkan Studies have been met.

There are currently 1-2 students working on the minor who have not yet filed their minor petitions. We would like to see that number grow to 4-6 enrolled with the changed requirements. This is a desired increase, and the administrators listed all have the capacity to serve these additional students as well as those anticipated in the associated Proposal for Revisions to the Graduate Minor in Russian, East European, and Eurasian Studies.

BUDGETARY AND STAFF IMPLICATIONS:

a. Additional staff and dollars needed:

None. The University of Illinois has become the premier interdisciplinary Balkan studies program in the country. Although it exists as faculty in diverse departments, the Russian, East European, and Eurasian Center provides these faculty with a formal body through which to offer an interdisciplinary minor.

b. Internal reallocations (e.g., change in class size, teaching loads, student-faculty ratio, etc.):

The primary effect will be an increase in students for the Director to advise. This is a desired increase, and both the Director and the other individuals listed above all have the capacity to serve these additional students as well as those anticipated in the associated Revision to the proposal for Revisions to Graduate Minor in Russian, East European, and Eurasian Studies.

c. Effect on course enrollment in other units and explanations of discussions with representatives of those departments:

There may be a small increase in enrollments in Balkan-related courses in other departments, which is seen as beneficial. The minor may result in enhanced recruitment for disciplinary departments of graduate students with an interest in the Balkans; however, those departments' recruiting policies would ensure that numbers are not excessive. The current minor was discussed and approved at the REEC Faculty Assembly, which included faculty from across campus, at the end of the 2003–2004 academic year. Current modifications were discussed and approved by the REEC Executive Committee, which includes members from the Departments of Anthropology, History, Library and Information Science, Law, Music, and Slavic Languages and Literature.

d. Impact on the University Library:

Our library already has stellar holdings and resources for the study of the region. The Slavic and East European Library is one of the best in the nation (certainly the best among state universities) and is surpassed in the size of its collections only by Harvard, Columbia, and the Library of Congress.

e. Impact on computer use, laboratory use, equipment, etc.:

No net impact, as this involves students already enrolled in Grad College MA and PhD programs.

Graduate Minor in Balkan Studies: The Balkan Studies graduate minor is designed for M.A. or Ph.D. students in other disciplines who desire to complement their degree program with interdisciplinary study of the Balkans. Students interested in pursuing the minor must have a minimum of two years of college-level study of a language of the region (e.g., Albanian, Bulgarian, modern Greek, Hungarian, Macedonian, Romani, Romanian, Serbian or Croatian, Slovene, Turkish, Yiddish). A program of study can be tailored to the needs and interests of the individual student in consultation with Center staff; for admission to the program contact the Center.

A research paper primarily on the Balkans is required. Normally, this paper would be written in a research seminar course in a disciplinary department. A master's thesis or doctoral dissertation can be submitted in lieu of the research paper, if it deals primarily with the region. Students are encouraged to present their work in a public forum at the University, such as the REEEC Noontime Scholars lecture series.

Thanks for your message. LIS 550 is also a core course in our MA program, where both it and REES 550 are required. So the minor parallels the major in that way. Our students have told us that it is a very useful course and that their research benefits greatly from it. REEEC and GSLIS take turns funding the course in alternating years and we are both committed to seeing the course offered on a yearly basis. It also attracts graduate students from Slavic and History, but the course is not at all at capacity. There is definitely room to accommodate a growth in REEEC minors.

Hi, David. Thanks for sending along the proposals to revise the graduate minor in Balkan Studies and the graduate minor in REEES. I think the proposals look good, and agree that moving them from 20 to 12 hours should make them much more attractive to students.

We'll plan to take these forward to our next C & C meeting. It's possible that the committee may question why an LIS course—LIS 530, the REEES Bibliography and Research Methods course—is one of two core courses in the minor, even though I know the revisions actually give students more choice now (either REEES 550 or LIS 530). Do you know whether GSLIS is supportive of continuing to offer the course on a regular basis (just in case this question comes up) and whether they can accommodate slightly more students if both minors should grow?
