#### **BRIEF DESCRIPTION:**

The Department of Urban & Regional Planning would like to rename and revise the existing undergraduate Minor in Urban Planning. We are proposing to change the name of the minor to Minor in Urban Studies and Planning. This proposed minor revision is part of a departmental shift away from breadth and towards depth. For example, we have submitted a proposal to reduce our BA core requirements from nine (9) to five (5) courses because we are adding concentration requirements. Similarly, we are proposing to reduce the minor core from four (4) courses to two (2). The revision will allow students to take four or five electives. The required hours will remain the same.

#### **JUSTIFICATION:**

The current minor requirements do not allow students to develop any depth. Our proposed minor will be more flexible and allow students to take a cluster of elective courses that complement their major as well as fit with their career goals.

## **BUDGETARY AND STAFF IMPLICATIONS:**

#### 1) Resources

The minor will continue to be administered by the Department of Urban & Regional Planning. The minor will likely attract more students, but the increases can be handled with existing resources. The proposed changes will require zero increase in staff or faculty dollars.

#### 2) Resource Implications

We expect that the revised minor will attract students from across campus. It is a small minor program and we do not anticipate any major issue with other departments.

We do not anticipate any major resource implications because our existing undergraduate program is not running at full capacity. However, we do expect some impacts. Specifically, we expect that the proposed changes will lead to a larger class size.

Computer use will increase slightly. The department is already expanding its capacity by renting computer lab space in other buildings for classroom use. We are also modifying our computer lab by providing access to software and data via cloud computing. Cloud computing enables students to access computer lab resources with their own personal laptops from anywhere on campus.

We anticipate little impact on the library.

## EXPECTED ENROLLMENT IN THE MINOR

Historically enrollment in the BAUP minor has been 15 to 30 students. Current enrollment is 23. We expect enrollment to range from 30 to 50 minors.

We do expect an increase in enrollment in the minor with the requested changes. This would be due not to a lowering of standards, but to the addition of flexibility. Currently, the 4 core classes are all lower level: UP 101, 203/204, 205, and 260. With only two of these being required, students electing to take the minor would have more flexibility in choosing courses to their particular interests within the field. For juniors and seniors, the flexibility would allow them to take more upper level courses, which would likely reflect specializations of interest to them.

#### **ADMISSIONS TO THE MINOR**

The Undergraduate Program Director reviews applications as they are received. Students must have at least 30 credit hours and at least a 2.75 GPA. An application consisting of fillin-the-blanks for contact information, student's major, and expected graduation date, along with a brief essay as to why they seek the UP minor, is also required. We accept applications on a revolving basis, with no deadline required, so at any given time, our number of minors is fluid.

Students applying to the minor are rarely rejected. If they are rejected, it is usually for failure to meet the minimum required GPA or in very rare cases, for lack of time to complete the requirements of the minor.

#### MINOR ADVISOR

The Undergraduate Program Director advises students enrolled in the minor through email and one-on-one meetings. In addition, the departmental website has information about the minor requirements. Students can also work with concentration faculty, if they opt to focus electives in one concentration area.

#### **CERTIFICATION OF SUCCESSFUL COMPLETION**

Successful completion of the minor is confirmed through the student's Degree Audit Report System (DARS).
