**BRIEF DESCRIPTION:** The School of Art + Design is revising the <u>first year</u> foundation curriculum. All students in the School take these required courses; therefore this revised curriculum will affect every major program of study in the School. The current freshman level courses in drawing, <u>design</u>, and art history are being revised or replaced, and additional courses are being proposed or are moving from the sophomore sequence into the freshman <u>sequence</u>. Please see revisions provided in the appendix.

**JUSTIFICATION:** In the fall of 2016, the School of Art + Design implemented direct admission into majors. All incoming <u>freshmen</u> must still complete the required <u>foundations</u> curriculum, <u>prior to</u> beginning the <u>core major</u> sequence in their sophomore year. Part of this shift to direct admission included the unanimous vote by faculty to also restructure the foundational year in a manner <u>that</u>: 1. Allowed <u>freshmen</u> to take a course in their major, and 2: Ensures that all <u>freshmen</u> experience the breadth of practice and expertise available in the nine degree-granting programs in the School. <u>This</u> would allow them the opportunity to switch majors, if appropriate, <u>prior to</u> the sophomore year.

#### For the Degree of Bachelor of Fine Arts in Painting

The curriculum in painting requires 122 credit hours and provides extensive training in preparation for professional practice as an artist.

The first year is devoted primarily to the study of design, composition, the acquisition of both representational and abstract drawing skills, and a beginning painting course. The second year concentrates on developing painting skills and techniques with further studies in drawing and composition. The last two years are devoted to the development of individual creative expression in painting and other media.

When followed by a program leading to a degree of Master of Fine Arts in Painting, this curriculum is recommended as preparation for a career as an artist and as a teacher of painting and drawing and related subjects at the college level.

# Foundation Year for All Art and Design Curricula

The School of Art and Design offers bachelor of fine arts degrees in art education, crafts, graphic design, new media, the history of art, industrial design, painting, photography, and sculpture. All major's first-year experience will include courses in drawing, 2D, 3D, and 4D practices. Specialization begins in the second year.

Courses in the history and appreciation of art and certain courses in studio work are open to students from other colleges of the University. A field of concentration in art history is also offered in the College of Liberal Arts and Sciences. The school occupies studios, computing labs, workshops, classrooms, and offices in several different University buildings.

A portfolio review is required for admission to the School of Art and Design.
