### PROPOSAL TO THE SENATE COMMITTEE ON EDUCATIONAL POLICY

**TITLE OF THE PROPOSAL:** Revision of Undergraduate BFA Programs in the School of Art and Design; College of Fine and Applied Arts. A change in the Art History course selection in the Freshman Foundation year.

SPONSOR: Robin Douglas, Associate Director, douglas@uiuc.edu, 333-7261.

**BRIEF DESCRIPTION**: This revision of the undergraduate programs reflects a change in Art History courses for Foundation Freshmen and provides a more rigorous and diverse curriculum. We are requiring the following:

- Students in the Foundation year choose any two of the following courses: ARTH 111, ARTH 112, ARTH 113, ARTH 114, ARTH 115 instead of the current requirement of ARTH 111 and ARTH 112.
- Students cannot count both ARTH 112 and ARTH 115 toward this requirement.

**JUSTIFICATION**: The revised choices provide an education that is more balanced and diverse culturally, temporally, and geographically. It allows students to choose from a variety of introductory courses that cover a variety of regions, cultures, and periods.

### **BUDGETARY AND STAFF IMPLICATIONS:**

a. Additional staff and dollars needed: No additional staff is required.

b. Internal reallocations (e.g., change in class size, teaching loads, student-faculty ratio, etc.): The proposed changes will reallocate the resources of the Art History Program internally but will not change course offerings beyond the changes already brought about by current budgetary pressures.

c. Effect on course enrollment in other departments and explanations of discussions with representatives of those departments: There should be no effect on enrollments in other departments.

d. Impact on library, computer use, laboratory use, equipment, etc.: none.

**GUIDELINES FOR UNDERGRADUATE EDUCATION**: The revised offerings will benefit the students because the course offerings will be more diverse culturally, temporally, and geographically.
