TITLE OF THE PROPOSAL: Request for Code for Foreign Language Area of Concentration in Korean in the BS in Elementary Education and the BS in Early Childhood

BRIEF DESCRIPTION: We request that a code for Korean be added to the Foreign Language Area of Concentration codes for the BS in Elementary Education and the BS in Early Childhood.

JUSTIFICATION: The BS in Elementary Education and the BS in Early Childhood programs require the completion of an area of concentration in order to meet Illinois State Board of Education criteria for certification at the Pre-K and K-9 levels. Foreign languages have always been acceptable to meet this requirement. Several candidates in these programs have requested to use Korean as their area of concentration. As a result of South Korea's increasing global stature, Korean is growing in importance as a foreign language for elementary teachers to know. The focused area of study in the Korean language will become part of the curricular requirements and be noted on the permanent academic transcript. One outcome of this will be the ability to track the fulfillment of this curricular requirement in the degree audit system.

BUDGETARY AND STAFF IMPLICATIONS:

- a. Additional staff and dollars needed: This proposal will affect only the Korean Language Program of the Department of East Asian Languages and Cultures. See attached letter of consent.
