I. CALL TO ORDER

A regular meeting of the University of Illinois Urbana-Champaign Senate was called to order at 3:12 pm with Vice Chancellor for Academic Affairs and Provost Andreas Cangellaris presiding and Professor Emeritus H. George Friedman, Jr. serving as Parliamentarian.

II. APPROVAL OF MINUTES

12/09/19-01 The minutes of the November 11, 2019 meeting were approved as distributed.

III. PUBLIC COMMENT

No requests received.

IV. SENATE EXECUTIVE COMMITTEE CHAIR'S REMARKS

Professor Rob Kar (LAW), a faculty senator and Chair of the Senate Executive Committee (SEC), noted that the Senate has kept a good pace this year, but reiterated the rules that were approved at the previous Senate meeting limiting the time allotted for introducing (5 minutes) and discussing (3 minutes) items of business.

Chair Kar also noted that this can be a stressful time of year with final examinations and the holidays. Please be mindful of your colleagues and students, and point them to the appropriate resources as needed.

V. CHANCELLOR'S REMARKS

Provost Cangellaris gave remarks in the Chancellor's absence. Cangellaris reiterated that friends, colleagues, students, etc. might be facing challenges and to reach out to the appropriate resources. The resources are in place to keep everyone safe and healthy.

The Consensual Relationship Policy Task Force report was recently released. The Task Force was chaired by Jamelle Sharpe from the College of Law. In preparing the report, the Task Force met with various faculty members and a number of student groups, and also included a University wide survey.

Sharpe and four others from this University are part of a working group that is developing implementation recommendations at the System level. At the University level, the Office of the Provost is working with the Office of the Vice Chancellor for Diversity, Equity, and Inclusion to consult with appropriate faculty groups, Senate committees, and other stakeholders.

VI. QUESTIONS

Faculty senator Gilmore (LAS) inquired about the consensual relationship policy and its application to almost everyone at the University, but was concerned that the report does not appear to take into consideration that some employee groups are unionized. Cangellaris responded that this concern has been raised and will be considered when moving forward with implementation.

BASIS FOR NOMINATION:

Lonnie Bunch III made history when he was the first African American named Secretary of the Smithsonian Institutions. In that capacity, he oversees the most prestigious and arguably most comprehensive museum complexes in the world. His portfolio includes 19 museums, 21 libraries, the National Zoo, numerous research centers, and several education units and centers. The Smithsonian, as this complex is commonly referred to, hosts upward of 30 million visitors a year and has an annual budget of \$1.2 million.

Previously, Bunch was the director of the Smithsonian's National Museum of African American History and Culture. When he started as director in July 2005, he had one staff member, no collections, no funding and no site for a museum. Driven by optimism, determination and commitment to build "a place that would make America better," Bunch transformed a vision into a bold reality. The museum has welcomed more than 6 million visitors since it opened in September 2016 and compiled a collection of 40,000 objects that are housed in the first "green building" on the National Mall.

EXCERPT FROM THE NOMINATION LETTER:

"While Lonnie Bunch was introduced to most people when he was named as Secretary of the Smithsonian, he was well-known to many others as one of the many scholars and museum specialists who have labored long and hard in the vineyards of the nation's museum community. In his capacity as historian and educator, he has been in the museum business for practically his entire career, including years of service in Illinois. From 1983 to 1989, Bunch worked as a curator and then as director at the California African American Museum. He has moved back and forth across the U.S. ever since. While he has had deep ties to the Smithsonian across the years – he was a curator at the National Museum of American History from 1989-1994 – among his most influential stints was as president of the Chicago Historical Society from 2000 to 2005. Now known as the Chicago History Museum, it is one of the oldest museums in the country. In addition to overseeing dynamic and innovative exhibitions and stewarding the organization's vast and diverse holdings of material related to urban midwestern life, Bunch ran a capital campaign that has enabled the museum to remain a leading local, regional, and national institution."

"But if there is a reason to single out Lonnie Bunch, it is for the extraordinary job he did in turning an idea that first surfaced in 1915 into a tangible national asset. Early in the 20th century African Americans called for a museum on the national mall that captured and expertly showcased the African American experience in and contribution to the nation. For nearly a century requests from Congress to authorize such a construction were ignored and deferred.

Eventually the opposition softened and the effort needed a leader. In 2005 Bunch was lured away from his job heading the Chicago Historical Society. He had been asked to transform an idea for a museum into the National Museum of African American History and Culture. Congress committed land but no resources. Bunch first had to assemble a management team. Then he had to build an advisory board, develop a concept for a museum on the mall, convince donors big and small to contribute, find an architect, assemble artifacts, and open. That he did so by September 2016 is a testament to all of his skills. He found others inspired by his vision for a museum, staff willing to serve, advisory members who gave and got financial support for the museum. And, ultimately, he found donors as committed as he to its opening."

BASIS FOR NOMINATION:

Jill Ellis is an exemplary leader and one of the most celebrated soccer coaches in the world. She is the winningest coach in U.S. soccer history and the only person to win back-to-back Women's World Cups. She has also used her athletics platform to champion efforts to close the gender pay gap and to celebrate LGBTQ inclusion. Illinois gave Ellis her first head coaching position in the first year we had a women's soccer program.

EXCERPT FROM THE NOMINATION LETTER:

"Ellis has said she credits her English degree with providing her insights into people and culture, and with the analytical skills she needed to relate to her teammates and to coach at the highest levels in her sport. Though her path had not been a traditional one for those who graduate as English majors, Ellis is an example of the power of English literature to prepare students for any career they wish to pursue.

Ellis was inducted into the William & Mary Athletics Hall of Fame in 2002, was named a William & Mary Tribe Champion for Life in 2015, and was honored as their 2018 Alumni Medallion. She also has an honorary doctorate from that institution. Off the field, Ellis has emerged as an advocate for addressing the gender gap, pushing for equal pay for equal work. After the 2019 USWNT win, several of her players brought renewed attention to the disparities between the salaries they made and those made by the U.S. Men's team, despite the latter's comparative lack of success internationally. Ellis was able to navigate her role as an employee of U.S. Soccer, while also supporting and inspiring her players to stand up for their rights. She has also been a role model for LGBTQ athletes by championing inclusion on her teams.

Ellis has had a tremendously successful athletics career. But more importantly, she has used her career to elevate issues that matter to her and her players that have broad social implications."

BACKGROUND

Responding to the Report of the Eighth Senate Review Commission (XSR.19.01), the Senate Committee on University Statutes and Senate Procedures (SP) examined its charge and composition as provided by the *Bylaws*, Part D.19.

The proposed changes better align this language with the committee's practice while also allowing SP to clearly address matters under its charge and that the Senate may direct to it. In particular, this proposal clarifies that SP reviews more than just the "form" of proposed amendments (a.1) and that the committee is often charged to advise the Senate on a variety of impacts and actions (a.3).

In addition, SP intends to recommend that its chair be released from other academic duties for one-half time, once an agreement has been reached on funding and terms of such releases. This recommendation mirrors the release for the chair of the Senate Executive Committee (*Bylaws*, Part D.1.c) and the chair of the Senate Committee on Educational Policy (*Bylaws*, Part D.8.c). The SP workload makes considerable demands on the chair's time and requires a significant commitment.

RECOMMENDATION

The Senate Committee on University Statutes and Senate Procedures recommends the approval of the following revisions to the *Bylaws*. Text to be deleted is struck through and text to be added is <u>underlined</u>. Adoption of amendments to the *Bylaws* requires a two-thirds vote of the Senate.

SP.20.12 Revision to the *Bylaws,* Part D.5 – Committee on Campus Operations

BACKGROUND

Responding to the Report of the Eighth Senate Review Commission (XSR.19.01), the Senate Committee on Campus Operations examined its charge and composition as provided by the *Bylaws*, Part D.5.

This proposed set of revisions would change the phrasing "instructional space" to "academic space" in D.5.a.5 to align the duties of the committee with the more general academic mission of the University and the role the faculty play in the overall governance process.

In addition, the Assistant Vice President for Business and Finance position specified in D.5.b.4 no longer exists; this proposal includes broader language for a representative from the Office of the Vice President and Chief Financial Officer, who would serve in an *ex officio* capacity, maintaining this function.

RECOMMENDATION

EC.20.03 Participation of Emeriti in the Senate and Senate Committees

BACKGROUND

The Senate Committee on Elections and Credentials Committee (EC) was charged with examining Recommendation #1 from the Eighth Senate Review Commission Report.

Specifically, that recommendation states:

#1 REVIEW THE PARTICIPATION OF EMERITI IN THE SENATE AND ITS COMMITTEES The recent governance audit noted the participation of emeriti as a topic of review in two of the past three Review Commission reports (XSR.00.03, Final Report of the Fifth Senate Review Commission, and XSR.15.01, Report of the Seventh Senate Review Commission), yet the topic never reached the full Senate as a discussion or as part of an actionable proposal. The SR recommends holding a Committee of the Whole Discussion (COTW) at a Senate meeting to discuss the role of emeriti in the Senate and on Senate committees. An informational document, created by SEC and included in the meeting packet, could start the COTW discussion with suggested paths forward. Those paths could include, but are not limited to:

- 1) Confirm the current emeriti participation.
- 2) Allow emeriti to serve only as senators, but not serve on committees.
- 3) Allow emeriti to serve on committees, but not serve as senators.
- 4) Allow emeriti to serve only on certain committees, but not as senators.
- 5) Limit emeriti service on committees, and allow emeriti to serve as senators.

EC discussed Recommendation #1 at its meetings on September 11, 2019 and October 2, 2019, and data detailing the numbers of emeriti faculty serving on the Senate and its committees were examined (see Appendix A).

The attached data shows that the total number of emeriti faculty serving as senators ranged from 6-9 and as members on Senate committees from 4-10. With total Senate membership ranging from 277-281 during this same of period of time, the total percentage of emeriti faculty serving as senators and on its committees represents approximately 3.25% of the overall population.

There was unanimous agreement by the committee that participation of emeriti faculty in the Senate provides an important contribution to the University because emeriti faculty provide institutional memory and invaluable experience, and represent another faction of the faculty.

RECOMMENDATION

The Senate Committee on Elections and Credentials recommends the Senate confirm the current practice of including emeriti faculty in the faculty electorate; therefore remaining eligible to vote and serve in the Senate and remaining eligible to serve on committees of the Senate.

EQ.18.04 Resolution on Employee Accessibility and Disability

WHEREAS, 15% of the world population has a disability (*World Health Organization*), 20% of the US population has an anxiety disorder in any given year (*Mental Health First Aid*), and 58% of people will experience a mental disability in their lifetimes (*Mental Health First Aid*);

WHEREAS, the University has an obligation to accommodate employees with disabilities due to the Americans with Disabilities Act (ADA);

WHEREAS, University employees face everyday accessibility challenges such as a deficit of accessible parking spaces;

WHEREAS; a Senate resolution can serve to publicize this important work to include constituencies whose voices will be important to its success;

WHEREAS, the Office of Access and Equity (OAE) has struggled to meet the accommodation needs of employees with disabilities in a timely manner due to issues involving adequate staffing, support for accommodations from units in which they are requested, and questions about sources of funding to comply with accommodation needs;

WHEREAS, like other universities, the University of Illinois at Urbana-Champaign lacks adequate data about employees with disabilities, their needs, or their accommodations;

WHEREAS, departments across the University are experiencing a rise in a demand for accommodations for employees;

WHEREAS, unmet accessibility needs can produce crises for faculty and staff faced with delays in the accommodation process and lack of understanding at the unit level;

WHEREAS, accessibility and accommodation support are factors in retention of faculty and staff;

WHEREAS, disability and accessibility are part of diversity, equity, and inclusion which are part of the University's Mission and Vision statements; and

THEREFORE, be it resolved, that the Senate encourages the administration to:

- Urge the office of the Vice Chancellor for Diversity, Equity and Inclusion to engage appropriate internal and external consultants to assess campus climate related to disability needs, collaborating with the Senate Committee on Equal Opportunity and Inclusion to target underserved faculty and staff in any survey collecting such information;
- 2. Ensure that the accommodations processes of the OAE are properly staffed and funded;
- 3. Educate faculty and staff to come forward with accommodation requests and properly support those requests;
- Consult with universal and accessible designs experts on and off campus to address facilities issues such as signage, accessible parking, and other building and workspace accessibility issues;
- 5. Comprehensively integrate issues of accessibility and disability in discussions on diversity, equity, and inclusion;
- 6. Conduct a policy and implementation review across all departments;
- 7. Require departments to include discussion of accommodation procedures as part of employee onboarding; and
- 8. Require sensitivity and empathy training for all supervisors in how they interact with their employees with disabilities.

Re: Proposed revisions to the *Statutes* (USC ST-77)

Dear Colleagues

We are arriving at the end of a multiyear process of revising the *Statutes* and *General Rules*. We want to bring you up to date about where we are in the process.

The three university Senates have reviewed the first round of proposed revisions to the *Statutes* (ST-77). We received different feedback from the three Senates (attached), to which we have responded, working with Executive Vice President Wilson and University Counsel. Because the Senate feedback was disparate, we faced a situation in which each of the proposed changes in ST-77 was approved by two of the three Senates, while each Senate individually requested changes that were not requested by the other two.

In cases like this, the *Statutes* direct the University Senates Conference to "endeavor to promote agreement of the senates" about the proposed changes (Article XIII Section 8). Our approach was to go as far as possible in accommodating each alteration of the proposed revisions suggested by each Senate; in some cases this meant accepting the proposal with revised language. In addition, working with EVP Wilson and Counsel, we also tried to accommodate their concerns so that the proposed changes we do send forward to the Board for final approval will have the support of the President. In some cases they objected to some proposed changes.

All the final changes are highlighted here in yellow.

This final draft of proposed *Statutes* revisions does not require further Senate action, and are being forwarded to the Senates for information. In accordance with the *Statutes*, each senate may

opt to forward its comments on any of the revisions proposed here, and those comments will be forwarded to the Board along with this draft of the proposed revisions. Should your Senate wish to forward comments, the Conference asks that you do this by March 2.

Please recall that there were other *Statutes* (ST-79, ST-81, and ST-82) and *General Rules* (GR-46) revisions which have already been approved/reviewed by the Senates. The Board prefers to receive all of these as one packet of changes, so when ST-77 is ready to go forward, we will compile a single document that includes all the proposed revisions.

Finally, there is a second round of revisions to the *Statutes*, ST-83, which includes important changes such as a revision to the definition of "faculty" to include non-tenure system faculty. We anticipate getting these to the Senates in the Spring semester, but we cannot do that until the process with ST-77 has been completed. And there are other *Statutes* revisions (ST-72 and ST-84) already in the pipeline; we hope that the Senates' work on those two proposals can be completed in the Spring.

Recommended revisions to ST-77 from the Senates

Springfield

THEREFORE, BE IT RESOLVED that the UIS senate accepts the revisions to the University Statutes as presented in USC ST-77, with the exception of Article IV, Section 4, line 953, where the words "and of the chancellor/vice president" shall be stricken, as follows:

If a change of organization is voted, the chancellor/vice president shall thereupon transmit this recommendation vote of the faculty along with the recommendations of the dean <u>and of the chancellor/vice president</u> to the president for recommendation to the Board of Trustees. Faculty of the department may communicate with the Board of Trustees in accordance with Article XIII, Section 4 of these Statutes. Not accepted. The language is a bit unwieldy, but the principle is that the chancellor/vice president can append their own recommendation along with that of the dean.

Chicago

The UIC Faculty Senate approved the following amendments to the proposed revisions to the *Statutes* (USC ST-77):

- Nondiscrimination Statement: The addition of the two categories of gender expression and citizenship status within the second paragraph of the Nondiscrimination Statement. The Senate concluded that the inclusion of the two categories would demonstrate University of Illinois leadership in regard to these important societal issues. Accepted with edits. Our Nondiscrimination statement follows the wording of Illinois state law, and gender expression is not a category in state law. The statement about nondiscrimination based on citizenship was accepted but moved to Article IX Section 1.
- Article I, Section 1 lines 257-258: Removal of the words "is appointed by the governor of Illinois and bears the ultimate responsibility to the people of the State". *The Senate concluded that the Statutes should not state who appoints the Board of Trustees, as the appointment is a process determined by the legislature.* Accepted.
- Article I, Section 2 line 269: The addition of the words "The University Senates Conference will be represented on that committee" to the prior sentence ending in, "...after consultation with a committee appointed for the purpose of recommending appropriate candidates." Not accepted. The composition of the search committee is up to the Board of Trustees. While USC has traditionally been represented, and should be, it was felt that specifying membership becomes a slippery slope. Why specify USC membership and not other

constituencies? In addition, we have tried to avoid mandating the behavior of the Board of Trustees in this document.

- Article I, Section 3 line 290: Restore the words "or reappointment." The UIC Senate was concerned that the compulsory advice from the University Senates Conference for reappointment has been dropped. This seems to be a bad precedent that diminishes the influence that faculty have, and in particular weakens faculty governance. Not accepted. Reappointment for every system officer (except the president) happens annually, which would be unwieldy for mandatory consultation in every case. The president's case is different (see below).
- Article I, Section 3, lines 296-297: Restore the content of lines 296-297 "Prior to the reappointment of the president, the Board of Trustees shall seek the advice of the University Senates Conference." The UIC Senate was concerned that the compulsory advice from the University Senates Conference for reappointment has been dropped. This seems to be a bad precedent that diminishes the influence that faculty have, and in particular weakens faculty governance. Accepted with edits, however we did not make it compulsory. Again, we have tried to avoid mandating the behavior of the Board of Trustees in this document.
- Article I, Section 5 in line 306: Replace "and" with a "/" in the title. Senators had recommended that in Article I, Section 5 the title in line 306 should read "Chancellor/Vice Presidents." Accepted.
- Section 5, Article I, line 321: Directly after the words "or a major review" add the words "or reappointment". Senators were concerned that in Article I, Section 5 the compulsory advice of the senate should be at least allowed for the reappointment of the chancellor. Senators reiterated that the proposed change seems to be a bad precedent that diminishes the influence that faculty have, and in particular it weakens faculty governance. "A major review" needs to be defined. Accepted with edits.
- Article II, Section 1 (e) line 374: Maintain the current language with no deletion of the words "new line of work involving questions of." Senators found the change of wording from "No new line of work involving questions of general educational policy" to a vague terminology of "changes to general educational policy" is problematic. Senators found that the prior language explicitly said that any increase in teaching duties, etc. needs to be approved by the senate. Senators stated that relinquishing that power is detrimental to faculty governance and may allow the administration to act unilaterally. Not accepted. We believe "new line of work" is being misread here. It does not pertain to specific changes in faculty work load or conditions. We believe that "changes" is more general and inclusive,

addressing any changes of that type, and much more. The principle of mandatory senate review is not compromised – indeed, it is <u>expanded</u> by this word change.

Urbana

Revised Preamble (merges original Preamble language with the new version):

The University of Illinois, as a state university created by statutory edict of the Illinois legislature, is subject to the control of the Illinois General Assembly. The General Assembly, subject to the limitations of the state constitution and to such self-imposed restraints as are essential to the maintenance of a free and distinguished University, exercises control by virtue of its authority to change the laws pertaining to the University and its power to appropriate funds for the maintenance and improvement of the University. Under existing state law the University of Illinois is a public corporation, the formal corporate name of which is "The Board of Trustees of the University of Illinois." Although there has been no formal, legal name change to the institution, as of May 20, 2016, the University of Illinois has adopted the organizational structure and nomenclature of a system for the effective and efficient impact, operation, and administration of the institution. The term "system" recognizes common components among the universities as well their organization under as a single governing board. Accordingly, the University of Illinois shall be referred to in this document and other governance and administrative documents as either the "University of Illinois System," the "U of I System," or the "system." It The University of Illinois System includes the University of Illinois at Urbana-Champaign: the University of Illinois at Chicago and its affiliated regional campuses in Peoria, Rockford, and the Quad Cities; and the University of Illinois at Springfield.

Within the limits fixed by the Illinois constitution and laws, the Board of Trustees exercises final authority over the University <u>System</u>. For the proper use of funds appropriated by the General Assembly and for the proper administration and government of the University <u>System</u>, the board is responsible to the people of Illinois, on whose behalf its members are appointed. The board is the governing body of the University <u>System</u> and exercises jurisdiction in all matters except those for which it has delegated authority to the president, other officers, or bodies of the University <u>System</u>.

The educational policy, organization, and governance of the University <u>System</u> as delegated by the Board of Trustees are promulgated in these **Statutes**. When acting on such matters, the board relies upon the advice of the university senates transmitted to it by the President of the University <u>System</u>, whose role is to set policy for system-wide endeavors and provide leadership at the state, national, and international levels for collective activities across the universities. In these matters each senate has a legitimate concern which justifies its participation in the enactment and amendment of

the *Statutes*. The Board of Trustees reserves the power to initiate and make changes in the *Statutes*, but before making any change it will seek the advice of the senates.

The General Rules Concerning University Organization and Procedure document supplements the Statutes. The General Rules are subordinate to the Statutes and deal with administrative organization, with the powers, duties, and responsibilities of officers of the University System, and with various administrative matters.

The Board of Trustees delegates to the President of the University <u>System</u> the authority to promulgate regulations and rules implementing *The General Rules Concerning University Organization and Procedure*. These are printed in the *Business and Financial Policies and Procedures* manual and other documents subordinate to the *Statutes* and *The General Rules* setting forth established policies and procedures. Led by a the President, The University of Illinois System is The University of Illinois System also comprises central administrative functions such as: (a) overseeing common fiduciary and compliance responsibilities; (b) providing certain shared services across the universities; and (c) coordinating system-wide data collection and reporting. The offices that provide services related to these activities are referred to as "system leaders."¹ The adjectival form for references to such activities is "system-level." To avoid confusion, these offices are not referred to as "the system."

The three University of Illinois System universities (University of Illinois at Urbana-Champaign, University of Illinois at Chicago, and University of Illinois at Springfield) are where the primary academic work of the system takes place, including: (a) research, scholarship and creative activities; (b) teaching, mentoring and degree granting; (c) public and professional service and engagement; and (d) economic development. Each university is separately accredited and is led by a chancellor who also serves as a vice president for the system. Accordingly, each institution is referred to in the governing documents as a "university," reserving the terms "campus" and "university campus" for references to their physical location and environment.

When referenced in the governing documents, "University of Illinois" and "University of Illinois System" refer to the institution as a whole, which includes the three universities as well as the system offices, and any other units associated with the institution as a whole. This larger organization is a single entity from the standpoint of state law and budgetary allocation. In shorthand, it is referred to as the U of I System or simply "the system." The adjectival form is "system-wide."

¹ In a few instances, such as University Counsel, offices have both a system-level and university footprint

<u>The University of Illinois, serves the state and the nation as a leader in public higher</u> <u>education and is governed by the Board of Trustees of the University Illinois ("Board of</u> <u>Trustees").</u> Accepted with edits.

Other proposed changes:

A. Article IV, Section 2.a: while revised, the proposed language retains a passive construction that makes the process of evaluating department chairs unclear. The proposed sentence reads "the performance of the chair shall be evaluated at least once every five years." SP recommends the addition of the following phrase: "in a manner to be determined by the faculty." A similar lack of clarity exists in Article IV, Section 3.a, regarding the review of department heads. SP recommends the same addition. Accepted with edits: the process should be specified in department, school, or college bylaws that should define the faculty role. But the dean is also going to want a role in dept head/chair evaluation, and we did not think it was statutory to try to specify that process in every unit.

B. Article IX, Section 1: two uses of "system" seem warranted in this paragraph and should be included. Accepted with edits.

C. Article IX, Section 2: the single word "knowingly" has both been added and then struck by USC, which if included, would modify "participate in institutional decisions involving a direct benefit [...] to a member of the [employee]'s immediate family." Without an additional rationale, SP recommends retaining the word "knowingly" as a modifier of the phrasing that follows. Not accepted. This section delineates when involvement in a decision pertaining to a family member is inappropriate, and "knowingly" (or not) is not a condition for that. This section is not intended to be punitive.

D. Article IX, Section 3.a: the phrase "appointments, reappointments, and promotions of system-level administrative staff" should include "academic or" before "administrative." Accepted.

E. Article IX, Section 11.a: this sentence has been expanded. SP recommends breaking the revised sentence into two, with the first sentence ending "…is located" and the second reading "If policies differ at each university, the system-level human resources office shall adopt one policy…" Accepted with edits.

F. Article IX, Section 11.b.5: the shift to "system" language changes the meaning and reference here. SP recommends that the phrasing read "on the basis of continuous employment in university academic administrative and professional positions…" and that the passage close with "relevant experience in any other University of Illinois System positions." Accepted with edits.

G. Article X, Section 1.a: the shift to "system" language here does not work. SP recommends that the end of the first paragraph read "a candidate for a degree from a university in the University of Illinois System." All degrees are (technically speaking) granted from the University of Illinois. That's what is on the diploma. Changing that would require more than statutory language can provide.

H. Article X, Section 1.a.7: the addition of "and are" changes a serial list after "or" to a different, more stringent list; SP recommends not inserting "and are." Not accepted. The sequence delineates a range of conditions, linked by "or." Adding this language would restrict the range of people covered.

I. Article X, Section 1.e.8: the phrase "of the Faculty Advisory Committee of the relevant university" has been added to indicate that that body should receive notice of charges of certain forms of reassignment of duties. SP recommends the modifier "appropriate" and that the subsequent phrase "or in the absence of the chair" be set off by commas. Accepted.

J. Article XII, Section 2.b: a new phrase has been inserted that reads "or by special arrangement approved by the system chief financial officer or designate." The last word should be "designee." Accepted.

K. Article XII, Section 3, paragraph 2: this passage addresses patents on inventions. SP finds that commas and the word "and" should be added to clarify the passage and recommends this paragraph read: "An inventor, whose discovery or invention is subject to the conditions of the previous paragraph, is required to disclose the discovery or invention to the system and may be required to patent the discovery or invention, and shall execute any documents necessary to perfect the assignment of such a patent to the system, the expenses therewith borne by the system." Accepted with edits. The added commas change a restrictive to an unrestrictive clause. But we agree that the sentence is unwieldy and needs to be cut in two.

SUR.20.01 Report on SURSMAC* Meeting November 15, 2019

SURSMAC held its Fall Meeting at the State Universities Retirement System (SURS) headquarters in Champaign, Illinois, beginning at 10 a.m. on November 15, 2019. Those attending were welcomed by Roger Spayer, SURSMAC Chair. The agenda included SURS updates and the Annual Meeting of SURSMAC.

The first speaker was Executive Director Martin Noven. He discussed several issues that he presented in his article "Adding Options, Maintaining Outstanding Service" on page two of the July 2019 issue of *The Advocate* newsletter from SURS. These will include revamping the Self-Managed Plan, creating a new supplemental plan open to all members, and a new supplemental plan for Tier II members to enhance their future monthly retirement income. They are also creating additional tools to help new hires make their initial plan election.

He also described the actions they are taking given that the expiration date for the two optional buyouts plans being offered by the state has been extended through 2024. Of particular interest is the new tool available on their website allowing individuals to compare their lifetime monthly benefit against the value of the voluntary buyout. It will show the estimated total dollar amount an individual would be giving up by electing a buyout. As he noted, it is the fiduciary obligation of the SURS to provide the most accurate information to help those eligible to make the best decision for their long-term financial benefit.

The second speaker was Doug Wesley, the Chief Investment Officer, who provided an investment update. As of September 30, 2019, the SURS investment performance for the year of 12.1% was similar to SURS' market goal as had been the case for each longer interval reported from three years to 20 years). The funding ratio is 44%. He noted that they had effectively implemented their Manager Diversity Program with MWDB (Minority-, Women-, and Persons with Disability-owned business) managers representing 33% of all managers and managing 33.9% of the total fund. He concluded by discussing some of the steps being taken to change the composition of the SURS investment portfolio.

The final speaker was Kristen Houch, Legislative Liaison, who presented a legislative update. She noted that (a) the FY 2020 budget included the \$1.855 billion certified contribution required under Illinois law and (b) the bill repealing retroactively eliminating the "6% to 3% Rule" was passed so that the University's pension liability during the period of time used to calculate an employee's pension would be for salary increases exceeding 6% rather than 3%. When asked about the status of "Tier III" she noted that though it was the law, it could not be put into effect until clarifications had been made.

Chair Spayer thanked the speakers for their presentations and called the SURSMAC Annual Meeting to order. The minutes for the May 9, 2019 meeting were approved as amended. Larry Curtis, SURS Employer Services Manager, presented a summary of the SURSMAC Member Survey. A majority felt that SURSMAC was important and a good use of their time but felt that there could be improvements in its operations. There was a discussion of what steps might be taken to improve the effectiveness of SURSMAC. The final action of the Committee was to elect as officers for the next two years Roger Spayer to serve as Chair and Melanie Lewis to serve as Vice Chair.

There being no further new business, the meeting was adjourned sine die at approximately 12:15 p.m.

SC.20.09 Report on the January 16, 2020 meeting of the Board of Trustees of the University of Illinois System in Chicago

Opening Events

The Board held an election of the Board's officers. Chairman Donald J. Edwards was nominated and elected unanimously for another term. Trustees Ramon Cepeda and Patricia Brown Holmes were elected unanimously to the Executive Committee. The Board Secretary (Dedra Williams), Comptroller (Avijit Ghosh), and University Counsel (Tom Barrows) were re-elected.

UIC Chancellor Michael Amiridis provided an update of news and events from his campus. He highlighted distinguished faculty achievements and emphasized the need for more faculty hires and their centrality to the teaching, research, and public impact of the university.

President Tim Killeen offered a presentation, "Empowering Extraordinary." This is the second of a planned series of four presentations. President Killeen highlighted the potential of the University of Illinois to be a "pre-eminent national model" of public higher education for the 21st century. This talk focused on the research and innovation mission, and the centrality of outstanding faculty to success in this context. He itemized a number of past and current faculty achievements in research and innovation. Trustee Smart said the presentation "gave her chills."

Executive VP Barb Wilson offered a presentation on tuition, fees, and housing costs. She reiterated the system's commitment to maintain accessibility. Financial aid has tripled over ten years. The Illinois Commitment program has significantly helped. Due to the five-year tuition freeze, Urbana is now fourth among peer institutions in tuition, and the gaps are closing. Several universities are facing increases which will probably move them ahead of Urbana. The need for more faculty hiring and better salaries requires new revenues, justifying the proposed "very modest and sub-inflationary" tuition increase.

Public Comments

There was one public speaker, Jonna McHugh from the Engineering Career Center at UIC. She identified inadequate compensation and benefits for low-wage university workers, which she argued are below market rates, and their consequences for overwork, stress, and unsafe working conditions.

Board Decisions Affecting the Entire UI System

Before voting, Trustee Edward McMillan said that while he supported the tuition increases, he wanted to see greater emphasis on lowering overall costs in higher education and seeking non-

academic cost savings in the budget. Trustee Stuart King offered a statement in agreement, saying that he wanted assurances that tuition revenues would be used efficiently and effectively. Trustee Ric Estrada commented on the potential impact of tuition increases on students from lower-income backgrounds. Trustee Ramon Cepeda agreed, as did Student Trustee Susan Panek. Board Chairman Don Edwards concluded that "at this point, this is the responsible thing to do . . . We can't sustain a freeze forever."

Approve contract extension for Timothy L. Killeen as President, University of Illinois. Following a "robust and thorough" Board review of his five-year performance, the new term of employment will be for four years commencing July 1, 2020. Dr. Killeen will receive an annual base salary of \$835,000, subject to annual increases consistent with the University's annual merit-based salary program.

Approve Gregory J. Knott, previously Assistant Dean of University Libraries at Urbana, to serve as Secretary of the Board of Trustees and of the University, non-tenured, on a twelve-month service basis, on 100 percent time, at an annual salary of \$182,500, beginning June 1, 2020. Mr. Knott is succeeding Ms. Dedra Williams, who is retiring June 1, 2020, after serving as Secretary of the Board of Trustees and the University for four years.

Revisions to University Policy Background Checks: these revisions are mostly minor updates to "system/university" language in the document.

Approve Tuition Rates, Academic Year 2020-2021 20. The increase at Urbana is 1.8% for both resident and non-resident students. This increase is locked in for four years for new incoming students.

Approve Student Fees for Urbana, Chicago, and Springfield, Academic Year 2020-2021 21. At Urbana, this will mean an increase from \$1,543 to \$1,581 (2.46%).

Approve Rate Changes for University-Operated Housing Facilities, Urbana, Chicago, and Springfield, Academic Year 2020-2021. At Urbana, this will mean an increase of 3.65 percent, following two years of no increases and a smaller increase of 1.5 percent last year. Students who continuously live in University Housing residence halls will pay the same room and board rates from their time of entry, for up to four years.

Senate committees are authorized to act for and in the name of the Senate on minor matters. Below is a listing of the administrative approvals the Senate Committee on Educational Policy approved at its meeting on January 27, 2020. Additional information for each approval is attached.

A. Undergraduate Programs

- Journalism minor In the list of courses from which students are to select 6-7 hours, *remove* JOUR 421, Editing for Publication (3 hours) and *add* JOUR 220, News Editing (4 hours). JOUR 421 has not been offered for several semesters, whereas JOUR 220 is regularly taught and fits well with the minor. There is no change to the total number of hours required by the minor.
- 2) African Studies minor Update the list from which students are to select one course to remove HIST 110, History of Africa (3 hours), which has been discontinued effective Fall 2020, and replace it with HIST 111, History of Africa to 1800 (3 hours), and HIST 112, History of African from 1800 (3 hours). There is no change to the total number of hours required for the minor.
- 3) Political and Civic Leadership minor Replace PS 199, Undergraduate Open Seminar with PS 191, Topics in Civic Leadership (1-2 hours) as a course of which students are required to take at least two sections for at least 2 hours for the minor. Delete the footnote that referenced PS 199. There is no change to the total number of hours required for the minor.
- 4) Bachelor of Science in Human Development and Family Studies Remove major-specific Quantitative Reasoning II general education requirement, allowing any successfully-completed course from the campus-approved list to fulfill this requirement. This does not change the total number of hours required for the major.
- 5) Bachelor of Landscape Architecture Remove GEOG 103, Earth's Physical Systems (4 hours) as an option to fulfill the major's physical science general education requirement. This course is no longer offered. Editorial revision to remove duplicate "for the degree of..." statement in the program of study listing. Corrected total hours, which were summing to indicate a range, to reflect the actual minimum for the program, 124.
- 6) Leadership Studies minor The Agricultural Education Program was renamed the Agricultural Leadership, Education, and Communications Program effective for Fall, 2019. In parallel to this name change, the program established a new course subject, Organizational and Community Leadership (LEAD), and are converting courses that existed under the AGED course rubric to the LEAD rubric. This revision updates the Leadership Minor's Program of Study listing to reflect the LEAD rubric, replacing AGED 260 with LEAD 260, Foundations of Leadership (3 hours); AGED 380 with LEAD 380, Leadership in Groups and Teams (3 hours); AGED 480 with LEAD 480, Collaborative Leadership (3 hours); and AGED 340 with LEAD 340, Leadership Ethics & Society: Addressing Contemporary Challenges (3 hours).

Additionally, in the list of electives from which students are to choose 5-6 hours, remove ACE 293, Offcampus Internship (1-4 hours); and add ACES 298, International Experience, Leadership Experience to Rome section (3 hours); and remove SE 462, Leading Sustainable Change (3 hours), which has been discontinued. There is no change to the total number of hours required for the minor.

7) Agricultural, Consumer, and Environmental Sciences Minor – In the list of "Global Study in the Social Science Disciplines" courses from which students are to select a minimum of 3 and a maximum of 9 hours, remove EPS 426, Comparative Education (3 hours), as this course has been deactivated. Twenty-six courses remain as options in this list, and there is no change to the total number of hours required for the minor.

B. Graduate Programs

1) PhD in Human Development and Family Studies – Update the list of Substantive Courses from which students are to select four courses (8-16 hours) to remove HDFS 525, Family Interaction (4 hours) and WGGP 581, Gender Relations & Intl Dev (4 hours), and to add HDFS 529, Youth and Family Acculturation (2 hours); HDFS 541, Inequalities In A Diverse Society (4 hours); HDFS 561, Child and Family Program Dev (4 hours); HDFS 562, Child & Family Program Eval (4 hours); HDFS 595, Seminar (1-4 hours); and RST 586, Health and Leisure in Recreation, Sport and Tourism (4 hours). The revision is anticipated to alleviate students' issues with having a time-lag between when courses on this list are offered and when students need to take them.
