The BFA Theatre core curriculum is being revised (key 146), along with the 8 current BFA Theatre concentrations (keys 679, 680, 681, 682, 683, 684, 685, 686), a newly proposed concentration (Art & Entertainment Technology-key 950), and the Theatre Studies minor (key 147). An attachment with all changes for the major and its 9 concentrations are provided comprehensively in the BFA Theatre program page (key 146).

This revision for the Sound Design and Technology concentration eliminates 3 courses and adds 3 courses and clarifies 3 category lists of electives into 2 category lists of electives, with no change in total credit hours. Enclosed EP.19.24 is a previously approved proposal (approved by Senate on 12/10/2018 for fall 2019) from the College of Fine and Applied Arts to revise the BFA in Theatre, including four of its concentrations. The credit hours for this concentration do not change.

THEA 153 is added and THEA 453 is eliminated. THEA 153 and 453 share the same course name (Intro to Theatre Sound), but 453 is open to both undergrad and grad students. By requiring 153 instead of 453, it supports a cohort experience for undergraduate students as part of the concentration requirements.

THEA 425 is eliminated and THEA 225 is added, both of which have a drafting focus.

The 3 elective categories are revised into 2 elective categories, consisting of similar courses.

A note is added to clarify the THEA 100 requirement in addition to the BFA Theatre core.

THEA 199 was a temporary course and a permanent course, THEA 119, is newly proposed in the CIM workflow to replace it. see attached.
