**The credit hours for this concentration do not change.**

**THEA 153 is added and THEA 453 is eliminated. THEA 153 and 453 share the same course name (Intro to Theatre Sound), but 453 is open to both undergrad and grad students. By requiring 153 instead of 453, it supports a cohort experience for undergraduate students as part of the concentration requirements.**

**THEA 425 is eliminated and THEA 225 is added, both of which have a drafting focus.**

**The 3 elective categories are revised into 2 elective categories, consisting of similar courses.**

**A note is added to clarify the THEA 100 requirement in addition to the BFA Theatre core.**
