Interdisciplinary Health Sciences (I-health), a program within the College of Applied Health Sciences (AHS), offers a bachelors degree at the University of Illinois. This program, that began 10 years ago, has flourished, with over 350 undergraduate majors. Over most of its history, the I-health program was housed in the College of Applied Health Sciences as a "stand alone" major. More recently, steps are being taken to relocate the I-health program within the Department of Kinesiology and Community Health in the College of AHS. The Dean of the College of AHS, Dean Cheryl Hanley-Maxwell, recommended that I-health function within the Department of Kinesiology and Community Health to realize the benefits of functioning within a well-established academic unit. A primary benefit includes the opportunity to engage in the Department of KCH's educational policy governance. The faculty and staff affiliated with the I-health program have already been functioning as part of the Department of Kinesiology and Community Health, so this change would result in minor, if any changes for faculty, staff, and students in the program.
