#### **Common Parliamentary Procedures for the Urbana-Champaign Senate**

#### Introduction of business:

By an individual senator or group of senators (Pre-filed Resolution listed on the Senate agenda):

"I move the adoption of resolution RS.20.00" (substitute the assigned resolution number). A second is required.

By a committee (an item listed on the Senate agenda):

"On behalf of the Xxx Committee, I move the adoption of XX.20.00" (substitute the committee name and the assigned business number). No second is required. Business not on the Senate agenda (New Business):

"I move to admit the following item as New Business" (*briefly* describe the proposed business). A second is required. If this motion is approved by the Senate, the item is effectively added to the meeting agenda. One can then move to adopt the item. A second is required. Debate may then take place on the item, but, per the Open Meetings Act, no final vote can be taken at this meeting. However, motions such as amendments or referral to committee can be made and voted on. Unless postponed or referred to a committee, the item will be placed on the agenda of the next meeting.

#### To change a motion:

To edit the text of the motion:

"I move to amend the motion by changing xx to yy on line ##" (insert the desired text to be changed, and indicate the line number if the original text is numbered). To substitute an entirely new text for the original:

"I move to substitute the following for the motion" (state the substitute motion).

It is most helpful if the text of the amendment is made available to the Clerk in writing or by email for display on the screen.

In either case, a second is required. Debate must then be confined to the wisdom of the amendment; general discussion oi the main motion must await the outcome of the vote on the amendment.

There is no such thing as a "friendly amendment" which is automatically adopted if the maker of the original motion is agreeable. Use the motion to amend.

#### **Disposition of business:**

To refer to a committee:

"I move to refer this matter to the Xxx Committee" (substitute the committee name). One can add, "with instructions to" do whatever.

Or: "I move to refer this matter to a committee selected by the Senate Executive Committee". Instructions can be added.

A second is required. Either of these motions can be amended as to the choice of committee and/or the instructions to the committee.

To postpone the matter:

"I move to postpone this matter indefinitely." If adopted, this effectively defeats the original main motion. A second is required.

Or: "I move to postpone the matter" to a specific future meeting or for a specific period of time. A second is required.

#### To lay on the table:

The motion to lay on the table is *not* appropriate for this purpose. Use one of the motions to postpone.

#### To terminate discussion:

To terminate discussion of the current motion to amend or to refer to committee:

"I move to close debate on the current motion."

To terminate discussion of the main motion as well as all pending subsidiary motions (such as to amend or to refer to committee): "I move to close debate on the current motion and on the main motion."

In either case, a second is required, and a 2/3 vote is necessary to close debate.

The motion to "call the previous question" is equivalent wording; it means exactly the same thing as the motion to "close debate."

## BACKGROUND

The Senate Executive Committee shall initiate and guide the work of the Senate; coordinate and evaluate the activities of the Senate committees; prepare the agenda for Senate meetings; schedule and supervise the organizing of the Senate in accordance with Part A of the Senate *Bylaws;* nominate members of the Committee on Committees; provide advice annually, as requested, to the Chancellor on the annual appointment of the vice chancellors; provide advice annually to the President on the annual appointment of the Chancellor; review Campus Budget Oversight Committee, Research Board, and Research Policy Committee nominees; and perform such other duties as the *Statutes* or Senate shall specify.

The Chair of the Senate Executive Committee shall establish and maintain liaison with the offices of the President of the University and the Board of Trustees on matters of major concern to the Senate.

The Chair and a Vice-Chair, shall be elected by ballot by and from among the membership of the Senate, and who shall be the presiding officers of the Senate Executive Committee.

## STATEMENT OF INTEREST AND EXPERIENCE

#### Robin Kar (Professor, LAW)

Professor Kar is a Professor of Law, with a joint appointment in Philosophy. He has a BA, in philosophy (with a minor in physics) magna cum laude (Harvard); a JD from Yale Law School; and PhD in Philosophy (University of Michigan). He clerked for the Honorable Justice Sonia Sotomayor.

As 2019-2020 SEC Chair, Professor Kar helped develop new mechanisms to ensure strong shared governance on time-sensitive policy decisions during the COVID-19 pandemic. He was the 2018-2019 Vice Chair. Kar has also engaged in numerous other campus and system-level service positions. For some examples: Kar chaired the Committee on Faculty Sexual Misconduct, which produced substantial recommendations to reorganize the University's responses to sexual misconduct. He sits on the University Senates Conference, participated in the naming rights working group, helped develop and draft system-wide comments and objections to the Department of Education's proposed Title IX regulations, and helped manage the production of system-level guiding principles to foster healthy relationships across the campuses. In all these positions, Kar has sought to empower faculty and other senators by guiding their engagement and representation in broader campus and system-wide efforts. Kar would continue those same efforts next year.

Kar's interdisciplinary scholarship easily crosses the North/South Campus divide. Areas of expertise include the evolution of morality; the prehistory of social complexity; religious tolerance; race in the genomic age; contract law and theory; history of same-sex marriage law; the impact of the digital world on traditional systems of private ordering; and harassment policy. Recently, Kar has begun to develop a new research area in the law and policy of higher education.

## STATEMENTS OF INTEREST AND EXPERIENCE

#### James Brennan (LAS)

James R. Brennan is Associate Professor in the Department of History, with a research focus on twentieth-century Africa. He is author of the book Taifa: Making Nation and Race in Urban Tanzania (Ohio University Press, 2012), which won the 2013 Bethwel Ogot Prize for best book in Eastern African Studies. He currently teaches courses on African History, Global History, and the History of Intelligence. He is a graduate of the University of Illinois (1991), and earned his Ph.D. at Northwestern University (2002). He has served on a number of UIUC senate committees, including Campus Operations, Military Education Council, and Admissions; he also currently serves as Chair of the UIUC Parking Advisory Committee. He has been a UIUC Senate representative member to the University Senates Conference (USC) since 2017, where his participation has largely focused on the USC's Statutes and Governance Committee.

#### William Maher (LIBR)

William Maher has previously served on the University Senates Conference 2013-19 and its Executive Committee (2018-19). His deep commitment to shared governance is evidenced by 18 years in the Senate and by the 2017 Campus Outstanding Faculty Leadership Award. He was member (2005-20) and chair (2006-17) of the University Statutes and Senate Procedures Committee and member of the Senate Executive Committee (2006-17). He has served on Chancellor search committees in 2011 and 2016. Throughout, Maher has provided an independent voice, critically assessing all calls, whether from administration or senators and evaluating initiatives and resolutions constructively without partisanship or preconceptions.

Maher has been Professor of Library Administration since 1977 and Director of University Archives since 1995. In 2017, Maher received the Chancellor's Medallion which the University has awarded on only six occasions. Beyond the University, he has held leadership positions in regional, national, and international organizations. His research focuses on archival management and intellectual property. He has served (2011-20) as an NGO head of delegation to the World Intellectual Property Organization to advocate for copyright reform.

## Mark Steinberg (LAS)

I have been a faculty member at UIUC since 1996 and active in the Senate for many of these years. I am currently a professor in the History Department and hold a zero-percent positions in the Department of Slavic Languages and Literatures and in the Unit for Criticism and Interpretive Theory. On the Urbana campus, I have been a member of the Senate Executive Committee; the Senate Committee on Academic Freedom and Tenure (I also served as chair); the Graduate College Executive Committee; the Executive Committee of the Russian, East European, and Eurasian Center; and the Executive Committee of the Department of History. I have been Associate Chair and Director of Graduate Studies in History. I have also participated in many policy drafting committees at the college (LAS) and at the University level, most recently committees on sexual misconduct and on controversial speech. For my research on Russian/Soviet history and comparative urban history, I received fellowships and grants from SSRC, NEH, Carnegie, Guggenheim, the American Institute for Indian Studies, and others. I have also served on the Executive Committee and as President of the Association for Slavic, East European, and Eurasian Studies and been editor of the association's professional journal, *Slavic Review*.

## Helga Varden (LAS)

Helga Varden is an Associate Professor in Philosophy (Ph.D. philosophy, University of Toronto, 2006) and in Women and Gender Studies. Though permanently at UIUC since 2006, she has held visiting positions at the University of Chicago, Northwestern University, and the University of St. Andrews. In addition to her book *Sex, Love, and Gender—A Kantian Theory* (OUP, 2020), Varden has roughly 50 publications in the areas of legal-political philosophy and its history, feminist philosophy, and the philosophy of sex and love. Along with these research activities, Varden has held leadership positions in general philosophical associations including the American Philosophical Association and the International Society for Law and Philosophy as well as in more specialized ones such as the North American Kant Society and The Society for the Philosophy of Sex and Love.
