## I. CALL TO ORDER

A regular meeting of the University of Illinois Urbana-Champaign Senate was called to order at 3:10 pm with Senate Executive Committee Chair Rob Kar presiding and Professor Emeritus H. George Friedman, Jr. serving as Parliamentarian. Chancellor Jones read the Land Acknowledgement Statement.

#### II. APPROVAL OF MINUTES

09/21/20-02 Without objection, the minutes of the May 4, 2020 and August 10, 2020 meetings were approved as distributed.

#### III. PUBLIC COMMENT

No requests received.

#### IV. SENATE EXECUTIVE COMMITTEE CHAIR'S REMARKS

Professor Rob Kar (LAW), a faculty senator and Chair of the Senate Executive Committee (SEC), asked for any objections to granting the following individuals floor privileges during the discussion of RS.21.02: Vikram Sardana (Former student SEC Member), Susan Zhou (Former student SEC Member), and Spencer Hulsey (Kingfisher Creator).

09/21/20-01 Without objection, floor privileges were granted to Sardana, Zhou, and Hulsey to speak during the discussion of RS.21.02.

Chair Kar thanked everyone for their participation in shared governance. The Senate has been responsive to the need to respond nimbly and get the right input to the right decision makers. Through collaboration, vibrant discussion, and debate, these processes have improved our institutional response to the pandemic. Kar also thanked the Chancellor and Provost, and their respective leadership teams, for their responsive efforts to meet with the SEC and Senate on an emergency basis.

Kar made the following announcements. The Senate Committee on Equal Opportunity and Inclusion (EQ) will hold a listening session for all faculty and staff on October 14 from 2:00-4:00 pm to hear feedback on possible revisions to the Senate's Diversity Values Statement (EQ.13.01). Additional listening sessions will be held on October 11 for the Cultural Houses, and on November 4 for students.

On behalf of David Lange as the Chair of the Senate Committee on Faculty and Academic Staff Benefits (FB), Kar noted that those enrolled in the SURS Self-Managed Plan will be affected by an upcoming change. If you currently enrolled in the SURS Self-Managed Plan, you should carefully read all e-mails from SURS sent over the past weeks. These e-

mails contain important information, including some deadlines that may be relevant to your retirement benefits and options. Some of those deadlines are as early October 1.

Chair Kar directed senators to the slide listing the current Senate committee vacancies, noted that nominees do not need to be senators, and encouraged individuals to nominate themselves or colleagues. The vacancies are as follows: Campus Operations – 2 faculty, Conference on Conduct Governance – 1 faculty, Faculty & Academic Staff Benefits – 1 faculty, Information Technology – 1 student, Library – 1 faculty, and Military Education Council – 2 faculty. To express interest or for more information, contact the Office of the Senate.

#### V. CHANCELLOR'S REMARKS

Chancellor Robert Jones thanked senators for their willingness to serve and he looks forward to working with senators through shared governance. Official enrollment numbers from the tenth day of classes. Even though the first-year undergraduate class is slightly down from last year at 7,530, overall enrollment is over 52,000. Online graduate enrollment has increased. Seventy-five percent of the first-year students are from the state of Illinois. The University of Illinois is the largest provider of undergraduate education in the state of Illinois. Underrepresented student number stayed relatively flat at 23.2%. Considering the pandemic, this number should be celebrated. Jones is pleased that growth gained over the last few year was sustained. These numbers are a reminder of the faith students and their families put into this University.

During the first week of the semester, the COVID-19 positivity rate was relatively low. Over the first weekend, there was a small spike in the positivity rate due to some unacceptable behavior by a small number of students. Because of rigorous testing the increase in positivity rate was identified early. There were some students that continued to hold or attend parties after testing positive, avoiding the Champaign Public Health District (CUPHD) contact tracers, and others that tested positive continued to return to testing sites in hopes of testing negative instead of remaining in quarantine as required. Steps were taken to identify and swiftly remove those individuals that engaged in unsafe activities. Students who did not want to comply with COVID safety precautions have been and will continue to be suspended. Jones stated that his advice in eight words is no parties, small safe gatherings, and smart decisions.

SHIELD Illinois is working to expand testing across the state of Illinois by working with the Governor's Office. Expansion is under consideration for the cities of Urbana-Champaign, K-12 students, nursing homes, and across the state.

Fall sports were postponed. Several student athletes tested positive for COVID and tested positive for myocarditis (inflammation of the heart muscle). Decisions were based on data and medical evidence. Student athletes came here to pursue certain academic goals and we want to make sure students can meet those goals. All 14

Chancellors of the BigTen made the commitment to clean practice fields and competition fields as football and other fall sports resume.

## VI. QUESTIONS FOR THE CHANCELLOR

Student senator Sinnokrot (LAS) asked if the university is taking any action against bars that are not in compliance with social distancing, nor wearing face coverings? Jones replied that the University has been meeting with bar and restaurant owners. Generally, bar owners have been trying to be responsible. Recent issues with noncompliance on wearing face coverings and practicing social distancing at local bars has been addressed. Partnership and community engagement are key. Patrons must take responsibility along with the owners.

Faculty senator Rosenstock (LAS) noted that there have been several assaults on academic freedom. The weaponization of Title VI of the Civil Rights Act against open criticism of racism is a very serious threat to academic freedom. Rosenstock asked if the Chancellor would commit his administration to the vigorous defense of academic freedom. Chancellor Jones replied that academic freedom is at the core of this institution and that the University will continue to do the right things. Systemic racism occurs at institutions across the nation. Jones sent a call for action to map out and respond to these inequalities; to do what is right and to do things that align with University values.

Faculty senator Steinburg (LAS) inquired about spring planning and conveyed student concerns regarding the additional anxiety being caused by a lack of a clear plan for the spring semester. Jones reiterated that the focus is to keep everyone safe. One of the top agenda items is to figure out what the spring semester will look like. The conversation has been started, but it is still in the early stages of development.

Faculty senator Mathisen (LAS) requested an update on the financial status of the University. Jones expressed his concern about the anticipated decline in tuition revenue. State funding will be the same as last year. State funding remains at the same level as last year along with no pay raises this fall. Jones was happy to report that the University has not had to lay anyone off.

## VII. INTRODUCTION TO SERVING AS A SENATOR

Chair Kar gave a brief overview stating that the Senate is an elected representative group of faculty, students, and academic professionals on campus. It brings these groups together under the umbrella of shared governance and responsibility for maintaining open lines of communication between these constituencies and the campus administration. The work of the Senate helps shape key policies, processes, and decisions of importance to our campus, community, state, nation, and world.

Kar noted the document distributed entitled the "Unofficial Guide to the Responsibilities of Being a Senator," which covers keys points of being an effective senator. This document is also available on the Senate website. Kar encourage those with experience and newer senators to connect to answer questions.

Senate Committees are central in the work of shared governance. The *Statutes* give the Senate jurisdiction over certain matters such as general educational policy. In matters outside of the Senate's jurisdiction, the Senate can play an important advisory role. The strength of the Senate's voice depends on the quality and thoughtfulness of deliberative processes and how well informed the Senate is when developing its advice. The Senate is often only one piece in the approval process within the University and/or System.

Kar shared basic information about the structure of meetings, the content of most Senate agendas, and the importance of reviewing the agenda and meeting materials prior to the meeting. Reading the materials in advance of the meetings prepares senators to effectively participate in Senate meetings. Senators have the privilege of the floor on all matters before the Senate.

SEC Members, Helga Varden, Pia Hunter, and Nicholas Burbules shared additional thoughts on being an effective senator.

Varden shared thoughts on Senate deliberations. When engaging with senators remember we are all in this together. There are no prerequisites for being able to contribute meaningfully and senators should feel comfortable speaking on issues where you have something important and relevant to add. The best decisions come from listening to one another and finding ways forward that are sensitive to the broad range of concerns that each senator brings to the Senate as representatives from different units and parts of the University. Varden also noted that the Senate is subject to the Illinois Open Meetings Act (OMA) which means the public, including the media, is always invited to attend meetings to listen to discussion.

Hunter offered two main points aimed at newer senators. First, remember to think broadly while representing your unit. Second, remember to communicate regularly with your units, especially on items that may be of special interest. Hunter encouraged units with multiple senators to consider meeting occasionally to discuss common issues and how best to raise them with the Senate.

Burbules discussed the importance of Senate committees. Most of the preparatory work of the Senate is done in and through Senate committees which develop most of the proposals for Senate action and that appear on the Senate agendas. Burbules encouraged senators to consider volunteering to serve on Senate committees. Most of

the detailed work of the Senate is done through its committees range from the budget, to student discipline, and educational policy matters. Burbules also noted that the most effective way to bring an issue to the Senate is through a Senate committee.

## VIII. REVIEW OF PARLIAMENTARY PROCEDURE

Parliamentarian H. George Friedman, Jr. reviewed basic parliamentary procedure and directed senators to the quick guide that was in the meeting packet. The quick guide is also available on the Senate website. Friedman gave various examples of motions and how those motions can be used effectively and appropriately.

EP.21.018 Revision to the 2020-2021 Academic Calendar (Spring 2021)

#### **BACKGROUND**

In response to the ongoing COVID-19 global health pandemic, the University of Illinois at Urbana-Champaign seeks to build on lessons learned from the fall semester to maximize the health and safety of our students, staff, faculty, and community members. Guiding factors from these lessons, which shape this proposal, are: Minimizing the number of times students leave and return to campus; providing adequate time at the start of the semester for COVID testing and isolation/quarantine protocols; recognition of the importance of days off for wellness; and avoiding Mondays, Thursdays, and/or Fridays for days off that lend to a long weekend, thus making travel more likely.

In addition, preservation of the spring semester end date is important for a variety of reasons, such as employment appointment dates, Commencement, and implications for the Summer, 2021 term. Discussions of these lessons learned and the potential impact of the recommendations in this proposal have taken place throughout the Fall, 2020 semester. The proposal is informed by input and feedback in these discussions with groups such as the Senate Committee on Educational Policy, the COVID-19 Executive Steering Committee, Council of Deans, and Council of Undergraduate Deans.

#### RECOMMENDATION

The Senate Committee on Educational Policy recommends the Senate approve the following changes to the 2020-2021 Academic Calendar (see appendix):

- 1) Revise the Spring semester start date from Tuesday, January 19, 2021 to Monday, January 25, 2021.
- Remove the Spring Vacation currently scheduled for Saturday, March 13, 2021 through Sunday, March 21, 2021
- 3) Add three non-instruction days off; no instruction on Wednesday, February 17, 2021; Wednesday, March 24, 2021; and Tuesday, April 13, 2021.

This proposal supersedes EP.21.001 to revise the 2020-2021 Academic Calendar.

## EP.21.018 — Spring 2021 Academic Calendar Revision FAQ

#### Q: What principles guided the proposed revisions to the Spring, 2021 Academic Calendar?

Revisions to the Spring, 2021 Academic Calendar are necessary in response to the COVID-19 global health pandemic. The proposed revisions:

- Acknowledge the importance of protecting the health and welfare of stakeholders, including students, faculty, staff, their families, and the community;
- Provide time in January for a staged return to campus for COVID testing and isolation protocols;
- Minimize the number of times students leave and return to campus;
- Recognize the need for breaks and wellness by adding single days without instruction;
- Avoid Mondays, Thursdays, and Fridays as days off to discourage three- to four-day weekend travel;
- Preserve the end date of the semester so as not to create conflicts with employment and/or appointment dates, Commencement, and the Summer, 2021 term.

## Q. Why not have a spring break week?

Health and safety of the campus and community are the primary drivers in this proposal. Based on the science behind and data from the COVID testing program, the Shield team strongly believes comings and goings must be minimized. A higher COVID positivity rate followed even the three-day Labor Day weekend, when students and staff were more likely to travel away from then return to campus. Any lengthy period of time in which there are not instructional days opens up more opportunities for such travel and, as a result, greater likelihood for positive cases, which can have significant impacts on the health and safety of not just those who are testing positive, but the larger campus and surrounding community as well. Hence, the proposal does not include a spring break week nor vacation days that are easily transferred to long weekends.

#### Q. Why not have a later spring break week then pivot to remote, similar to the Fall, 2020 semester?

This fall, we have learned that in spite of a pivot to remote later in the semester, many students are indicating they plan to be in the Champaign-Urbana area through the end of the semester. Many are bound by leases which factor into this decision. As such, and also based upon our experience with the Spring 2020 semester, we expect the same would be true if the pattern of a later break followed by a pivot were planned for spring. This means that those who travel over the respective breaks will be returning to the area following it, which increases health and safety risks. Additionally, pivoting to remote means faculty need to adapt their courses to fit this model. Finally, the pivot this fall also was factored into student fees, with a prorated reduction in certain fees when taking into account that students would have all online instruction after fall break. The fee structure for the fall semester has proven to be unwieldy and confusing for students and their families, and steps to streamline the fee assessment process moving forward has been called for by students, families, and the staff who work with these students to try to reduce confusion.

Although remote instruction at the end of the semester would help limit on-campus (e.g., classroom) transmission, we must also consider the health and safety of the broader Champaign-Urbana community. Therefore, large-scale COVID-19 testing must continue throughout the semester regardless of whether we are fully remote. If the semester were to end with remote instruction, understanding which students are local and which are not is quite challenging, making it more difficult to ensure that we are carrying out comprehensive COVID testing of all students.

## Q: What are the calendar policies impacted by the revision?

- 1.1, There shall be no fewer than 14 of each instructional day per semester and 13 weeks that have five full weeks of instruction (M-F). With two of the proposed days off being Wednesdays, the Spring, 2021 calendar will have 13 Wednesdays.
- 3.1, Classes shall begin on Monday 8 weeks after Thanksgiving week. If Monday 8 weeks after Thanksgiving week is a holiday, then classes will begin on a Tuesday 8 weeks after Thanksgiving week. The proposed calendar puts the start of the spring semester on Monday 9 weeks after Thanksgiving week.
- 3.2, Classes shall not be held on Martin Luther King Day or during a Spring Vacation that will be scheduled for either the ninth or tenth week of the semester. The proposed spring calendar does not include a Spring Vacation during the ninth or tenth week of the semester.

## Q: What is the impact on instruction days?

The proposal reduces total instruction days for the Spring, 2021 semester from 72 to 70. By weekday:

- 15 Mondays (1 extra)
- 14 Tuesdays (1 fewer)
- 13 Wednesdays (2 fewer)
- 14 Thursdays (same)
- 14 Fridays (same)

Ideally, sharing an updated calendar will allow time for instructional adjustments for MWF or MW courses such that the material "lost" in the 2 fewer Wednesdays can be distributed to the additional Monday and condensed if necessary then across other meeting dates. Tu/Th courses would need to condense material from the "lost" Tuesday.

## Q. What about courses with weekly lab cycles?

Single days off during the week does impact lab rotations. Knowing of this issue, Kevin Pitts, Vice Provost for Undergraduate Education, has been in contact with several departments that have weekly lab cycles. These departments understand the issues and are willing to work with it.

## Q. Why not "reprogram" one of the days of the week to avoid missing two Wednesdays?

These mechanisms have been used in the past and abandoned due to the significant confusion caused for students, faculty, and staff alike. Calling a Friday "Wednesday" to catch up on that particular day of the week is not manageable.

## Q: How does the proposed revision compare to other Big 10 schools' plans for spring, 2021?

- At least three other schools (Purdue, Wisconsin, and Iowa) are delaying the start of the spring semester by a week.
- Ohio State (1 week) and Indiana (3 weeks) will start the semester remotely.
- As of October 13, at eight Big 10 schools (Ohio State, Purdue, Indiana, Michigan, Wisconsin, Penn State, Iowa, and Nebraska) have announced they are not having a spring break.
- Three of the above institutions (Ohio State, Purdue, and Wisconsin) are adding a single day or
  multiple single days off over the course of the spring (Ohio State 1 Tu, 1 W; Purdue 1 Tu, 1
  W, 1 Th; Wisconsin 1 F).
- Michigan will end their spring semester one week early.

# Q. Why revise the calendar now rather than waiting until closer to the start of the semester to have a better understanding of the status of the pandemic at that point in time?

- Instructors need as much time as possible to make adaptations to their spring syllabi;
- Students, faculty, and staff need to know what to expect for the spring for a variety of reasons, including those who are planning obligations or travel over the winter and/or spring breaks;
- Decisions on the calendar is necessary for purposes of academic advising, adjusting dates such
  as add and drop deadlines accurately, and to allow the Shield Team to prepare plans for the
  return to campus testing and isolation.
- Once a calendar is settled, University Housing can begin concrete implementation plans for move-in/move-back for the spring. This planning is essential for students' returns to minimize density and stage testing schedules to ensure students, faculty, and staff can all be tested as needed with results returned for the start of instruction.

#### Q. What is the communication plan regarding the Spring, 2021 Academic Calendar?

A comprehensive communication plan is in place with Public Affairs. This plan includes key target audience messaging for students, faculty and staff, as well as publication of information via social media, websites, and the like.

The plan will be reflective of what is passed by the Senate and therefore dissemination of communications is pending Senate review and approval.

SP.21.01 Revision to the *Bylaws*, Part D.1.c – Senate Executive Committee (Chair and Vice-Chair eligibility)

#### **BACKGROUND**

Responding to the Report of the Eighth Senate Review Commission (XSR.19.01), the Senate Executive Committee (SEC) examined its charge and composition as provided in the *Bylaws*, Part D.1 and considered the Review Commission's recommendation that the SEC "determine additional eligibility criteria and duties for the positions of the SEC Chair and Vice-Chair" (XSR.19.01, Recommendation #5). The Senate Committee on University Statutes and Senate Procedures (SP) presented SEC's proposed changes to the *Bylaws* in SP.20.06, which included potential changes to SEC membership, the duties and eligibility of the SEC Chair and Vice-Chair, and vacancies in the Chair and Vice-Chair positions.

SP.20.06 was introduced at the July 13, 2020 Senate meeting, and included a proposal that would have restricted the eligibility for the SEC Chair to faculty or academic professional senators who have served at least one year on the SEC (at any time). That proposal also would have restricted eligibility for the Vice-Chair position to senators (of any type) who have served at least one year as a senator or on a Senate committee at any time. At the July 13 meeting, the Senate voted to amend the proposal to make the restrictions on the Vice-Chair match those proposed for the Chair position. The Senate also voted to return the proposal to SP for revision, including removing language regarding various types of vacancies in these positions that would no longer be necessary.

At its September 21, 2020 meeting, the Senate approved an amendment to remove both the restriction that the SEC Chair and Vice-Chair be faculty or academic professionals and that they have served on the SEC for at least a year. With those provisions removed, the Senate approved SP.20.06 as amended. However, the revised language (in lines 44-46) of SP.20.06 also changed the phrasing that specified that the Chair and Vice-Chair be elected "by and from among the membership of the Senate" while rephrasing the other proposed restrictions. This specification was thus inadvertently struck when the amendment to SP.20.06 was approved, substantively changing the eligibility for these positions.

Because the Senate has approved SP.20.06, SP recommends that it reinstate the restriction that the Chair and Vice-Chair be elected "by and from the membership of the Senate."

SP.20.15 Revision to the *Bylaws*, Part D.4 – Committee on the Budget

#### **BACKGROUND**

Responding to the Report of the Eighth Senate Review Commission (XSR.19.01), the Senate Committee on the Budget (BG) examined its charge and composition as provided in the *Bylaws*, Part D.4.

BG transmitted a set of proposed changes to the Senate Committee on University Statutes and Senate Procedures (SP) in October 2019. These were refined and strengthened by BG and SP, which after some delays due to the COVID-19 pandemic, were approved by BG in October 2020.

The proposed revisions better specify the committee's charge to advise work on behalf of the Senate to gather information and make reports and recommendations to the Senate as appropriate. These also align the committee's work with the new campus budget model and allow the committee to respond to the broader context of the University of Illinois System, instead of only the University of Illinois at Urbana-Champaign.

#### RECOMMENDATION

The Senate Committee on University Statutes and Senate Procedures recommends the approval of the following revisions to the *Bylaws*. Text to be deleted is struck through and text to be added is underlined. Adoption of amendments to the *Bylaws* requires a two-thirds vote of the Senate.
