CC.22.01 Election of the 2021-2022 Senate Executive Committee (SEC) Chair

BACKGROUND

The Senate Executive Committee shall initiate and guide the work of the Senate; coordinate and evaluate the activities of the Senate committees; prepare the agenda for Senate meetings; schedule and supervise the organizing of the Senate in accordance with Part A of the Senate *Bylaws*; nominate members of the Committee on Committees; provide advice annually, as requested, to the Chancellor on the annual appointment of the vice chancellors; provide advice annually to the President on the annual appointment of the Chancellor; review Campus Budget Oversight Committee, Research Board, and Research Policy Committee nominees; and perform such other duties as the *Statutes* or Senate shall specify.

The Chair of the Senate Executive Committee shall establish and maintain liaison with the offices of the President of the System and the Board of Trustees on matters of major concern to the Senate.

The Chair and a Vice-Chair, elected by and from among the membership of the Senate, and who shall be the presiding officers of the Senate Executive Committee.

STATEMENT OF INTEREST AND EXPERIENCE

Rob Kar (Professor, LAW)

Professor Kar is a Professor of Law, with a joint appointment in Philosophy. He has a BA, in philosophy, magna cum laude (Harvard); a JD from Yale Law School; and a PhD in Philosophy (University of Michigan). He clerked for the Honorable Justice Sonia Sotomayor.

He was SEC Chair for the past two academic years, and Vice Chair for the preceding year. He is currently Vice Chair for University Senates Conference at the system level. Though two years may be enough time for any one person to serve in this role, COVID has created unusual circumstances and some continuity in leadership may be useful for another year. Kar is therefore willing to serve if the Senate would like him to continue.

During his tenure as SEC Chair, Kar has helped develop and adapt mechanisms to ensure a strong voice for shared governance during the COVID-19 pandemic. He has also engaged in numerous other campus and system-level service or leadership positions. For some examples: Kar chaired the Committee on Faculty Sexual Misconduct, which produced substantial recommendations to reorganize the University's responses to sexual misconduct. He has served on University Senates Conference for several years, participated in the naming rights working group, helped develop and draft system-wide comments and objections to the Department of Education's proposed Title IX regulations, and helped manage the production of system-level guiding principles to foster healthy relationships across the campuses. He is a member of the AAUP Policy Committee.

In all these positions, Kar has sought to empower faculty and senators by guiding their engagement and representation in broader campus and system-wide efforts. He views his leadership style as emphasizing an ability to listen carefully to senators' (sometimes conflicting) views; and then helping ensure senators can make their views as effective as possible to ensure the Senate is placed in the best position possible to exert its will in an informed manner--all without taking sides on substance. If elected, Kar would continue those efforts next year.

Kar's academic expertise includes the evolution of morality; the prehistory of social complexity; religious tolerance; race in the genomic age; contract law and theory; history of same-sex marriage law; the impact of the digital world on traditional systems of private ordering; and sexual harassment law and policy. Recently, Kar has begun teaching seminars in the law and policy of higher education, thus adding an additional expertise that is relevant to this position.

Sara R. Benson is an Assistant Professor and Copyright Librarian in the University Library. Prior to that, she was a Lecturer at the College of Law for ten years. Sara has served in a variety of roles with the Senate in her many years at the University of Illinois including, as an elected member of the Chancellor Search Committee, as an elected member on the Senate Executive Committee, as an elected member of the Committee on Committees, as a co-Parliamentarian, as Chair of the Conference on Student Conduct, as Co-Chair of the Taskforce for Classroom Material Costs and more. Sara takes her service obligations seriously and is an active member of the Senate. Sara is going up for tenure this coming academic year as a member of the University Library faculty.

Nicholas Burbules (EDUC)

Nicholas Burbules has served on the Senates Conference (USC) several times and has chaired it twice. He is very familiar with the system-wide issues that USC deals with. Currently he is helping to lead a multiyear process of revising the Statutes and General Rules. The first round of those major changes went through last year. Next year the second round of changes will be moving through the USC and the Senates for review. John Dallesasse (ENGR)

Joyce Tolliver (LAS)

Joyce Tolliver is Director of the Program in Translation and Interpreting Studies and Associate Professor of Spanish & Portuguese. Her research and teaching deal with translation, gender, race, and sexuality in post-Empire Spain and the Philippines. She is a founding member of the MLA Global Hispanophones Forum and has chaired its executive committee, as well as serving as elected member of the MLA Delegate Assembly and division executive committees. NOMINATIONS

William Maher (LIBR)

William Maher has been a Professor of Library Administration since 1977 and University Archivist since 1995. He is committed to shared governance as seen in over 20 years in the Senate, as recognized by the 2017 Campus Outstanding Faculty Leadership Award. Previously he has served on the Senate Executive Committee while chair of the University Statutes and Senate Procedures Committee from 2006 to 2017. He has served on Chancellor search committees in 2011 and 2016. He has represented the UIUC Senate on the University Senates Conference 2013-18 and 2020-23. Throughout this service, Maher has pursued an independent position, critically assessing all calls, whether to endorse administrators' initiatives or to critique administrative initiatives. As USC representative to the Senate Executive Committee, he will look at each issue that comes forward without partisanship or preconceptions. Beyond the University, he has held leadership positions in regional, national, and international professional organizations. His research specialization is in archival management and intellectual property, and he has served as an NGO head of delegation in Geneva at the World Intellectual Property Organization since 2011.

Helga Varden (LAS)

Helga Varden is a Professor in Philosophy (Ph.D. University of Toronto, 2006) and in Women and Gender Studies. Though permanently at the UIUC since 2006, she has held visiting positions at the University of Chicago, Northwestern University, and the University of St. Andrews. In addition to her book—*Sex, Love, and Gender: A Kantian Theory* (OUP, 2020)—Varden has roughly 60 publications in the areas of legal-political philosophy and its history, feminist philosophy, and the philosophy of sex and love. Along with these research activities, Varden has held leadership positions in general philosophical associations, including the American Philosophical Association and the International Society for Law and Social Philosophy, as well as in more specialized ones, such as the North American Kant Society and the Society for the Philosophy of Sex and Love. Varden is an executive officer on the Editorial Board of the *Canadian Journal of Philosophy*—a top-ranked philosophy journal. Varden has served on the University Senate Conference since Fall 2020 and she currently serves as its representative to the Senate Executive Committee (AY 2020-2021). In her research, teaching, and service, Varden is committed to fostering scholarly excellence as well as improving diversity, equity, and inclusion throughout the academy.

Virginia R. Dominguez (LAS)

Virginia R. Dominguez (B.A., MPhil, and Ph.D. Yale) is the Gutsell Professor of Anthropology (and member of the Jewish Studies, Middle Eastern Studies, Global Studies, and Caribbean Studies faculty) at UIUC. She is also Co-Founder and Consulting Director of the International Forum for U.S. Studies (and Co-Editor of its book series, Global Studies of the United States). A political and legal anthropologist, she was president of the American Anthropological Association (2009 to 2011), editor of *American Ethnologist* (2002 to 2007), and Associate Editor of the *American Anthropologist* for World Anthropologies (2014 to 2021). Before joining the UIUC faculty in 2007, she taught at Duke, UC-Santa Cruz, and the University of Iowa, and held visiting positions in Paris, Manchester, Cape Town, Rochester, Honolulu, Jerusalem, and Harvard. She has been Interim Head of the UIUC Anthropology Department, now serves on the LAS Nominations Committee, and has served on several LAS special committees.

Cindy Ingold (LIBR)

Cindy Ingold is Gender Studies and Multicultural Services Librarian and Associate Professor in the Social Sciences, Health, and Education Library. She serves as departmental liaison to the Asian American Studies and Gender and Women’s Studies Departments, and to the American Indian Studies and Women and Gender in Global Perspectives Programs. She also provides outreach and services to several cultural and resource centers on campus. She is an active member of the American Library Association and the National Women’s Studies Association. Within the Library, Cindy has served as co-chair of the Library Diversity Committee for many years. She is also a member of campus diversity committees and the Faculty Senate.

Prasanta Kalita (ACES)

Dr. Prasanta K. Kalita is a Professor and Leader of Soil & Water Resources Engineering program of the Agricultural & Biological Engineering Department. He is the Director of the Appropriate Scale Mechanization Consortium and Faculty Affiliate of the Discovery Partners Institute. Currently he serves as the chair of the Honorary Degrees and a member of the Student Life Committees of the Senate. Previously, he served on the Senate Educational Policy Committee, chaired the Campus Committee on Race and Ethnicity, chaired the Committee on Committees, co-chaired the Teaching Advancement Board, chaired the Engineering Grievance Committee, and chaired many committees in both colleges of ACES and GCOE. He is a University of Illinois Distinguished Teacher Scholar and received the 2007 Campus Award for Excellence in Undergraduate Teaching. He served as Editor-in-Chief and Associate Editor of 3 international journals. Dr. Kalita is a Fellow of the American Society of Agricultural & Biological Engineers.

Rui Loja-Fernandes (LAS)

Rui L. Fernandes is the Lois M. Lackner Professor in the Department of Mathematics. He received his undergraduate degree from Instituto Superior Técnico, Lisbon, Portugal, and his master's and doctorate degrees from the University of Minnesota. His research interests include Differential geometry, Poisson geometry, integrable systems and Lie theory. He is the author of more than 40 research papers in peer-reviewed journals and 2 monographs, and he has supervised 6 PhD students. He is a fellow of the American Mathematical Society, and he has served in the Executive Committee of the European Mathematical Society and as the head of the Department of Mathematics, of Instituto Superior Técnico.

Angharad Valdivia (MDA)

Angharad N. Valdivia is Research Professor at the Institute of Communications Research. Common Parliamentary Procedures for the Urbana-Champaign Senate

Introduction of business:

By an individual senator or group of senators (Pre-filed Resolution listed on the Senate agenda):

“I move the adoption of resolution RS.20.00” (substitute the assigned resolution number). A second is required.

By a committee (an item listed on the Senate agenda):

“On behalf of the Xxx Committee, I move the adoption of XX.20.00” (substitute the committee name and the assigned business number). No second is required.

Business not on the Senate agenda (New Business):

“I move to admit the following item as New Business” (*briefly* describe the proposed business). A second is required. If this motion is approved by the Senate, the item is effectively added to the meeting agenda. One can then move to adopt the item. A second is required. Debate may then take place on the item, but, per the Open Meetings Act, no final vote can be taken at this meeting. However, motions such as amendments or referral to committee can be made and voted on. Unless postponed or referred to a committee, the item will be placed on the agenda of the next meeting.

To change a motion:

To edit the text of the motion:

“I move to amend the motion by changing xx to yy on line ##” (insert the desired text to be changed, and indicate the line number if the original text is numbered).

To substitute an entirely new text for the original:

“I move to substitute the following for the motion” (state the substitute motion).

It is most helpful if the text of the amendment is made available to the Clerk in writing or by email for display on the screen.

In either case, a second is required. Debate must then be confined to the wisdom of the amendment; general discussion of the main motion must await the outcome of the vote on the amendment.

There is no such thing as a “friendly amendment” which is automatically adopted if the maker of the original motion is agreeable. Use the motion to amend.

Disposition of business:

To refer to a committee:

“I move to refer this matter to the Xxx Committee” (substitute the committee name). One can add, “with instructions to” do whatever.

Or: “I move to refer this matter to a committee selected by the Senate Executive Committee”. Instructions can be added.

A second is required. Either of these motions can be amended as to the choice of committee and/or the instructions to the committee.

To postpone the matter:

“I move to postpone this matter indefinitely.” If adopted, this effectively defeats the original main motion. A second is required.

Or: “I move to postpone the matter” to a specific future meeting or for a specific period of time. A second is required.

To lay on the table:

The motion to lay on the table is *not* appropriate for this purpose. Use one of the motions to postpone.

To terminate discussion:

To terminate discussion of the current motion to amend or to refer to committee:

“I move to close debate on the current motion.”

To terminate discussion of the main motion as well as all pending subsidiary motions (such as to amend or to refer to committee):

“I move to close debate on the current motion and on the main motion.”

In either case, a second is required, and a 2/3 vote is necessary to close debate.

The motion to “call the previous question” is equivalent wording; it means exactly the same thing as the motion to “close debate.”

So referral gets voted on first; if it loses, then amendment; then the main motion. The main motion has the highest number, as it is always the last to be voted on.

An Unofficial Guide to
Responsibilities of Being a Senator

The Senate is the duly elected representative group of faculty, students, and academic professionals on campus. It brings these groups together under the umbrella of shared governance and responsibility for maintaining open lines of communication between these constituencies and the campus administration. The work of the Senate helps shape key policies, processes, and decisions of importance to our campus, community, state, nation, and world.

The Senate and its committees are the central locus for the work of shared governance at the campus level. The Senate has special authority over legislative matters relating to academic policies affecting this campus or the University of Illinois System as a whole.¹ Still, most Senate actions require approval from other actors within the university and system prior to implementation. Even when Senate input is not required, many non-academic policy matters can benefit from consultation and coordination with the Senate. The Senate is, accordingly, most effective when it maintains healthy and productive relationships with other actors within the university and system and can play an active and trusted role when addressing key policy questions. That is what shared governance entails.

Without your responsible participation, the Senate cannot be effective at meeting its goals.² Here are ten key areas of responsibility that are critical for your effectiveness as a senator.

- 1. Attend Meetings Regularly.** As your unit's elected representative to the Senate, you are responsible for keeping in regular contact with your unit about Senate business and helping the Senate act on its agenda in each session. Many Senate actions require a quorum. Losing quorum can require the Senate to postpone time-sensitive matters and may require scheduling additional Senate meetings during the term. You are therefore expected to attend Senate meetings regularly and to plan to remain for the full length

The Senate—sometimes through its committees or joint appointments of its members—is regularly consulted by the administration for input and advice on matters of policy.

of each meeting (which is regularly scheduled to last until 5:15 pm but may sometimes end earlier).

If you have a regularly scheduled conflict with Senate meetings or must regularly leave early, it is best to resign your seat and let your unit know so that it can promptly elect another representative who will be available to help conduct Senate business. If you must miss an occasional meeting or leave early on occasion, notify the Senate Clerk, Jenny Roether (senate@illinois.edu), prior to your absence so that the Senate can prepare to manage quorum.³

- 2. Be Prepared to Discuss and Vote.** Prior to each Senate meeting, you should review the materials on the agenda, especially those on the Action Agenda. These materials will be distributed in the week prior to the meeting. You should be ready to vote on any action items and participate in any discussions or motions relating to them. As a senator, you have the right to speak candidly for or against any item being considered, to make motions to amend from the floor, and to vote your conscience. Individual votes are taken publicly and become part of the Senate record.

You should also familiarize yourself with the [University of Illinois Statutes](#), the [General Rules Concerning University Organization and Procedure](#), the [Senate Constitution](#), [Senate Bylaws](#), and [Senate Standing Rules](#). The former two documents are system-wide documents that constitute the Senate, describe its statutory powers, responsibilities, and relations to other offices, and set forth the procedures by which the Senate operates. The latter documents concern internal rules of the Urbana Senate. Due to jurisdictional considerations, Senate actions and policies are only valid to the extent that they are consistent with these governing documents. Some of the most important and enduring actions the Senate can take involve proposed modifications to these governing documents. (Think of amendments to the U.S. Constitution.)

- 3. Try to Address Complex Issues in Advance.** If you have questions or concerns about an action item that might be addressed prior to a Senate meeting, you should consider contacting the sponsor (usually a committee chair or senator) before the Senate meeting. Although it is not uncommon for the Senate to vote for some amendments on proposals from the floor, it is usually inefficient to try to wordsmith complex documents before the full Senate without sufficient advance thought and preparation. Sometimes concerns can be addressed by suggesting revisions or amendments in advance and by obtaining a sponsor's agreement, which can greatly facilitate an amendment process proposed on the Senate floor.

³ Because your colleagues in your academic unit deserve to be represented in the Senate, if you miss two consecutive meetings without notifying the Senate Clerk in advance, it will be presumed that you have resigned from the Senate ([Senate Bylaws A.12](#)).

- 4. Learn How to Make Your Voice Effective.** As a senator, you may bring any issue of concern to the Senate Executive Committee or to a Senate committee that is charged with a particular issue. You may also propose action items to be placed directly on the Senate Agenda. When considering whether to pursue that latter option, it is wise to consult with the Senate Executive Committee, whose members may have advice that can help you produce proposals that will yield a productive Senate debate and vote. Most action items on the agenda are drafted and sponsored by a Senate committee, and it will often be worthwhile to address your concerns to the committee that has information and expertise on that particular issue. The members of the Senate Executive Committee may also know of related campus efforts or committee proceedings that are relevant to your concerns. They may be able to suggest particular stakeholders that would be worth consulting before bringing your item forward.

Given the number of stakeholders that are typically interested in Senate actions, unvetted proposals are usually not the most effective way of producing a desired outcome. The full Senate will typically take action items much more seriously if they have been vetted or even sponsored by a Senate committee or the Senate Executive Committee.

- 5. Volunteer for Committees to Ensure Your Voice Has Impact.** You should consider volunteering for Senate committees. Almost all of the Senate's most important work begins in committees, and committees are where the most extensive and detailed attention can be given to complex matters. Committees typically have special institutional information and experience related to their subject matters. Your contributions are likely to have a greater impact if you work on a committee that is charged with subject matters of interest to you than if you only raise or debate proposals from the Senate floor. When considering insufficiently vetted proposals from individual senators, the Senate Executive Committee or the Senate as a whole will, in fact, often refer the item to a relevant committee before bringing the item back to the full Senate floor.
- 6. Think Broadly, Even While Representing Your Unit.** The Senate is a representative democracy, not a direct democracy. As a member of a representative body, you should become informed about the issues, talk with colleagues both inside and outside of your unit, and in the end follow your conscience in judging what actions are best for your unit, the university, and the system. While you are elected to be an informed representative of your unit, you are not required to submit items for a local referendum.
- 7. Communicate Regularly with Your Unit.** Regardless of how you vote, you should keep your unit informed about actions the Senate is considering or taking that are especially relevant to your unit. Posting e-mail summaries of such actions and events after Senate meetings is one way to do that. Regular reports at your unit's faculty meetings or to your dean or department head can also help keep your unit informed. Keeping open lines of communication can help ensure that you are capable of representing any views or

concerns that are especially relevant to your unit consistent with your considered judgment. If you come from a unit with multiple senators, you might also consider meeting from time to time to discuss common issues and concerns and how best to raise them with the Senate.

- 8. Discuss and Debate Responsibly.** You should strive to express your opinions during Senate meetings and to your colleagues in reasoned, non-confrontational ways that respect the integrity of the Senate and your administrative colleagues and the value of their time and points of view. Remember that senators are all volunteers, serving to advance the good of the whole as they see it, just as you are. The Senate often serves as the public face of shared governance for the campus, and Senate meetings offer primary contact points between the Senate’s constituencies and the central administration. As a voice for shared governance that operates within a larger institutional context, the Senate is most effective when it maintains productive relationships among its constituencies and with other actors at the campus and system-wide levels.

At the beginning of each Senate meeting, the Chancellor or the Chancellor’s designee will typically provide remarks relevant to the state of the campus or current events. These remarks will be followed by a regular question and answer session. These are opportunities for you to learn about ongoing campus efforts, raise any questions or concerns, and help foster healthy and productive relationships with the administration.

- 9. Consider Your Audience.** You should bear in mind that decisions made by the Senate on this campus can affect not only our own faculty, academic professionals, students, and staff, but larger trends in higher education at the system-wide level, across state, throughout the nation, and even around the world. Senate meetings are open to the media and to the public. The tone and content of Senate deliberations is one measure of the health of a campus community.

- 10. Feel Free to Be a Strong Voice for Budget Transparency, Shared Governance, and Academic Freedom.** Though the Senate is only one part of a larger institutional system, it plays a distinctive role. Consistent with the Senate’s unique role within the campus and system, you should always feel free to encourage budget transparency, principles of shared governance, and academic freedom at all levels of campus governance.
