1. CALL TO ORDER – ANNUAL MEETING OF THE FACULTY

The 2024 Annual Meeting of the Faculty was called to order at 3:10 pm by Professor Emeritus H. George Friedman, Jr. serving as the Presiding Officer of the Senate with William Maher serving as Parliamentarian.

a) LAND ACKNOWLEDGEMENT STATEMENT

Chancellor Robert Jones read the Land Acknowledgement Statement.

b) PRESIDENT’S REMARKS

President of the University of Illinois System Timothy Killeen shared the following remarks. The University has had some challenges and issues, and yet the University is doing well. The University of Illinois is in a bit of a bubble in many ways, politically, geographically, intellectually, but there is momentum. A recent survey of citizens outside the university found that the sentiment towards the University of Illinois is improving, and trust and confidence is growing along with innovation and affordability.

Enrollment has been growing over the past decade, from 78,000 in 2014 to 97,000 in 2024. There has been a continued tuition freeze, but a modest increase is currently being discussed with the Provost and Deans. The System maintains high retention and graduation rates, and financial aid has doubled over the past decade despite national trends. The university consistently outperforms national averages.

Research funding has reached a record \$1.2 billion. Collaboration and partnerships with other institutions both in the state and internationally are strengthening the University’s impact. Every public university in the state is part of the Illinois Innovation Network (IIN) consisting of 15 hubs. International partnerships include Singapore, Mexico, Brazil, Canada, Germany, United Kingdom, and more to come.

The loyalty and generosity of donors remains strong. Philanthropic contributions have nearly doubled over the last ten years and is close to breaking the half of a billion dollars mark. Contributions support scholarships, professorships, and initiatives like the Herbert M. and Carol H. Retzky College of Pharmacy in Chicago and the Siebel School of Computing and Data Science in Urbana.

President Killeen concluded his remarks with his usual optimism, expressing pride and confidence in the university’s future contributions and impact.

c) CHANCELLOR'S REMARKS

Chancellor Robert Jones began by discussing how the University's role is not only as a land-grant university, but as a global institution. Chancellor Jones shared some highlights of his recent travel to Brazil and the Brasillinois initiative. Deepening the University of Illinois System's presence in Brazil is at the forefront of this initiative.

In addition to being in Brazil, Illinois hosted the Brazilian Agricultural Research Corporation (Embrapa). Embrapa is the agricultural research arm for the entire country. When visiting, they were able to see firsthand the digital agriculture enterprise and learn about the innovative work being done in the Soybean Innovation Lab and the farmdoc project.

Chancellor Jones mentioned other radical collaborations to address the grand challenges that are too large and too complex for any one entity to solve alone. These radical collaborations are on the cutting edge of addressing global issues and include the following initiatives. (1) Dr. Kelvin Droegemeier, one of the most noted climatologists in the world, joining the University to not only help document the impact of global climate change, but also mitigate the damage with increasing predictability. (2) The *World of Genomics* traveling exhibition presented by the Carl R. Woese Institute for Genomic Biology (IGB) to make the broadest impact on the largest audience, and also encourage more young people to consider the field of genomics or STEM related disciplines. And (3) The City Colleges of Chicago is partnering with the University to offer their School of Engineering students a seamless transfer path to the University of Illinois and address the shortage of engineers.

The new Office for Online Learning promotes equitable and accessible education opportunities to enrich the lives and the learning opportunities for Illinoisans as well as those throughout the country and across the globe.

Chancellor Jones also noted that unlike many other institutions announcing a decline in enrollment, Illinois announced a record-breaking enrollment for this year's first year class of which over 70% are Illinois residents.

Later this week the Grainger College of Engineering will celebrate the establishment of the Siebel School of Computing and Data Science through the \$50 million gift from Tom Siebel.

d) OPEN DISCUSSION

Several faculty members spoke against the proposed revisions to the *Statutes* referred to as ST-83 and urged the President not to send the proposal forward to the Board of Trustees. These professors expressed concern that revisions contained in ST-83 would be detrimental to the University by significantly changing who enjoys academic freedom.

Chancellor Jones reiterated how important academic freedom is and it stands as one of the core tenets of this University that must be protected. Chancellor Jones stated that the issues of academic freedom have never been more fundamental to what is required to

remain a world class University and to do cutting edge research and innovation. President Killeen added that academic freedom is central to who we are and how we must behave. Killeen also noted that he understands the Urbana Senate has significant reservations about ST-83 and he is not currently prepared to offer ST-83 as an item for the Board of Trustees to consider. Killeen said it was time to refresh the *Statutes*, but we want to get it right.

One professor called for the University to craft a policy on academic integrity similar to existing policies for data integrity.

Several faculty members also expressed concerns for students facing disciplinary action that were involved in protests this past spring semester and the role the University of Illinois Police Department (UIPD) played in the situation. Faculty members also expressed concern regarding making comments about Palestine, Israel, Gaza, and violence in the Middle East.

Chancellor Jones stated that the UIPD is responsible for the investigation of any alleged policy or law violation, and the States Attorney is responsible for any charges that may be brought against anyone.

e) CLOSING

The Annual Meeting of the Faculty concluded at 4:10 pm.

7. SENATE EXECUTIVE COMMITTEE CHAIR'S REMARKS

Faculty senator and Senate Executive Committee (SEC) Chair Jon Hale (EDUC) acknowledged October 7 as Indigenous People's Day and the one-year anniversary of the tens of thousands who have lost their lives in Gaza, Palestine, and across the Middle East. The Senate remains a space where voices need to be heard as it continues to move as one governing body to articulate shared notions of freedom and the practice of shared governance.

Chair Hale urged attendance at the upcoming Forum on Free Speech and Academic Freedom that will be held on October 28 at the Illini Union from 3:00-5:00 pm. This is an important venue to share your voice as senators and to also invite your colleagues to join as well.

Today's agenda appears to be light. However, it is important to fill committee vacancies to continue the work of the Senate and commitment to shared governance. An example of how impactful committee work can be is both the Senate Council on Student Conduct Expectations and Accountability and the Senate Committee on Student Discipline. These committees have been tasked to apply their understanding of freedom of expression and free speech in cases where students have chosen to protest and are now facing disciplinary action. Vice Chancellor Danita Brown Young recently shared with Chair Hale that her office received over 3,000 emails regarding these student cases related to student encampments and protests.

Chair Hale stated that he and the SEC are committed to ensuring the Senate produces an appropriate substantive response and transmits it to President Killeen by the December 16 deadline. In preparation of this response, the Senate will hold a committee of the whole discussion at the November 11 Senate meeting. Hale asked individuals to remain committed to engaging with the Senate and its committees despite busy schedules. Hale ended by thanking senators for their service and commitment to shared governance.

Faculty senator Clancy (LAS), as a newly elected member of the Senate Committee on Student Discipline, expressed concern about the transparency of disciplinary procedures and the involvement of UIPD in these cases.

Faculty senator Gertner (ENGR) questioned why Chair Hale did not specifically mention that October 7 was the biggest atrocity that happened to the Jewish people since the Holocaust. Chair Hale responded that his earlier comments did include the mention of tens of thousands of lives that were lost and thanked Gertner for sharing concerns as the Senate is a safe place to address these types of issues.

In response to a request, Chair Nolan Miller made a motion to amend EP.25.020 by adding the following statement to all future Academic Calendars:

“The schedule of final examinations for the colleges of Law, Veterinary Medicine, and the Carle Illinois College of Medicine, including their days and times, may differ from the

standard calendar. Students should check with the appropriate college regarding final examinations.”

The motion was seconded, and voting followed.

By i-clicker and show of hands, and Poll Everywhere, the motion to amend EP.25.020 was approved with 142 in favor, 1 opposed, and 3 abstentions.

By i-clicker and show of hands, and Poll Everywhere, the motion to approved amended EP.25.020 was approved with 138 in favor, 1 opposed, and 4 abstentions.

b) CC.25.12* Election of Members on Standing Committees of the Senate at the October 14, 2024 Senate Meeting

On behalf of the Senate Committee on Committees (CC), Chair Chaya Sandler presented and moved approval of the slate of nominees. Presiding Officer Friedman called for nominations from the floor.

Student senator Patrick Holt (ACES) nominated himself from the floor to fill the student vacancy on the Senate Committee on Honorary Degrees. Nominations were declared closed and voting followed.

By i-clicker and show of hands, and Poll Everywhere, item CC.25.14 as amended was approved with 137 in favor, 4 opposed, and 3 abstentions.
