# UNIVERSITY OF ILLINOIS URBANA-CHAMPAIGN SENATE MONDAY, NOVEMBER 11, 2024 3:10 – 5:15 PM ILLINI UNION BALLROOM & ZOOM MINUTES

# 1. CALL TO ORDER

A meeting of the University of Illinois Urbana-Champaign Senate was called to order at 3:13 pm by Professor Emeritus H. George Friedman, Jr. serving as the Presiding Officer of the Senate with William Maher serving as Parliamentarian.

#### 2. Approval of Remote Participation

Remote participation was approved by unanimous consent.

# 3. Approval of Floor Privileges

# 4. APPROVAL OF MINUTES

#### 6. SENATE EXECUTIVE COMMITTEE CHAIR'S REMARKS

Faculty senator and Senate Executive Committee (SEC) Chair Jon Hale (EDUC) began by noting two items on today's agenda from the Committee on Educational Policy (EP) – EP.25.034 proposes to eliminate the \$15 fee for students who register after the first day of classes. This change is due to the streamlined process of late registration. And EP.25.024 proposes the establishment of a Center for Research and Innovation and Technology-Enhanced Learning in the College of Education. This Center will bring together scholarly teams from across campus to provide a hub for research and innovation on the Illinois campus for investigating the multitude of ways new technologies impact learning and education. Ordinarily, proposals like EP.25.024 to create a new center would appear on the regular agenda. However, with today's full agenda and overwhelmingly positive feedback, it is on the consent agenda.

Chair Hale also highlighted the path ST-83 has followed so far and noted his concern that the three senates have not given adequate time to review and respond to the substantial and comprehensive proposes changes to every article in the *Statutes*. Hale also noted that SP.25.03 will guide discussion during the committee of the whole.

# 7. CHANCELLOR'S REMARKS

Bill Bernhard, Executive Vice Provost for Academic Affairs and Interim Associate Chancellor and Vice Provost for Budget and Resource Planning, shared remarks on behalf of Chancellor Robert Jones. Chancellor Jones and Provost Coleman are attending the annual APLU (Association of Public & Land-grant Universities) meeting.

Bernhard thanked everyone for their participation in the Forum on Free Speech and Academic Freedom. The University is fully committed to upholding and protecting free speech and academic freedom in all forms. It is truly one of the values that enables faculty to pursue the big ideas that will change the trajectory of our society.

The Boldly Illinois strategic framework builds on the University's values, goals, vision, and mission, and will be launching soon. Boldly Illinois is not prescriptive in laying out specific goals and objectives for the next six years. Instead, it defines our mission and shared values. It also offers planning resources for campus units and individuals. The framework is meant to align the University behind our vision of making the world a better place through bold ideas, innovation, education, and engagement. We look forward to your partnership on putting that strategic framework into action.

As a public institution, no matter the result, elections at any level invariably affect us in terms of funding, policy mandates, and regulations. There will be lots of discussions in the coming weeks and months about what this may mean as we move forward into 2025 and beyond. The University's governmental relations professionals will work to understand what the future might hold and how to be a good advocate for students, faculty, staff, and the institution. Many units across our campus are creating opportunities and spaces for everyone, particularly

students, to process the election, to evaluate what happened, to understand the election in context and historical perspective, and to assess possible consequences.

A few years ago, the University revised its procedures for promotion and tenure. One of those changes was the opportunity for candidates for tenure and promotion to share their professional activities related to diversity, equity, and inclusion. The DEI statement was introduced as an optional statement with the expectation that it would become a requirement for candidates being considered for promotion in fall of 2025. Last week, an announcement was made that keeps the statement as optional for fall of 2025. It will remain optional while a task force is charged to review what has been learned so far.

# **8. QUESTIONS FROM SENATORS**

Student senator Crystal (LAS) asked if there are plans in place to accommodate future large classes, given the record-breaking incoming class this year and the housing issues that followed, and to ensure affordable housing on campus. Bernhard shared that some of the growth has been planned and some was unplanned. The yield rate for admitted students was greater coming out of the pandemic than anticipated, which created pressure on campus resources, particularly with student housing. University leadership has had many conversations identifying appropriate targets for enrollment for next year. If continued growth is planned, it needs to be done thoughtfully and strategically. An enrollment target for next year has not been identified yet.

Faculty senator Belmont (LAS) requested a discussion about what the academic rigor is that we aspire to and what would be considered academic misconduct similar to the standing policies for scientific misconduct. He also stated that he was disturbed by Chair Hale's remarks at the last Senate meeting being used as an example of a lack of rigorous speech. Chair Hale replied that his intent was to be inclusive and remembering tens of thousands of lives lost and humanizing a tragic loss of life and apologized if that was not clear.

Faculty senator McDuffie (LAS), in light of the recent presidential election, expressed concern about the well-being and safety of all members of the campus, especially students of color. He encouraged speaking out against all forms of racism, sexism, homophobia, Islamophobia, and anti-Semitism.

Faculty senator Clancy (LAS) asked what the ways are that the university is going to protect community members, students, staff, and faculty from contentious events that lie ahead. Bernhard shares concerns about the unequal treatment and enforcement of University policies. The University will work to make sure there continues to be an environment that is welcoming and open to students from all walks of life, and to make sure that they feel that they have a place here at the University of Illinois.

#### 9. CONSENT AGENDA

The following items were approved by unanimous consent.

- a) EP.25.027\* Eliminate the Concentration in Athletic Training in the Bachelor of Science in Kinesiology in the College of Applied Health Sciences
- **b) EP.25.028\*** Eliminate the Bachelor of Science in Athletic Training in the College of Applied Health Sciences
- c) EP.25.034\* Revise Section 3-307 of the Student Code (Late Registration Fee)

Faculty senator Gilmore (LAS) requested EP.25.024, Establish the Center for Research and Innovation in Technology-Enhanced Learning in the College of Education, be moved from the consent agenda to the proposals section of the agenda.

#### 10. PROPOSALS

a) EP.25.024\* Establish the Center for Research and Innovation in Technology-Enhanced Learning in the College of Education

Nolan Miller, Chair of Educational Policy, gave a brief overview of the required procedure that were followed, noted that feedback at each stage of approval was overwhelmingly positive, and moved approval of EP.25.024.

Faculty senator Gilmore noted that he requested the Senate vote on this proposal based on past conversations in the Senate that supported voting individually on all new centers. There was no additional discussion and EP.25.024 was approved by unanimous consent.

b) CC.25.13\* Election of Members on Standing Committees of the Senate at the November 11, 2024 Senate Meeting

Chaya Sandler, Chair of Committee on Committees (CC), Chair Chaya Sandler presented and moved approval of the slate of nominees. Presiding Officer Friedman called for nominations from the floor.

Faculty senator Stirek (LAS) made a self-nomination to fill the faculty vacancy on the Senate Committee on the Budget. Nominations were declared closed, and voting followed.

By i-clicker and show of hands, and Poll Everywhere, the motion to amend CC.25.13 was approved with 145 in favor, 2 opposed, and 2 abstentions.

#### 11. COMMITTEE OF THE WHOLE - 60 MINUTES

SEC Chair Hale made a motion to move into a committee of the whole. The motion was seconded and approved by unanimous consent.

# SP.25.03\* Committee of the Whole Discussion Regarding the Amended Proposed Revision to the Statutes (USC ST-83 Revised)

David Dalpiaz, Chair of University Statutes and Senate Procedures (SP), read SP.25.03 aloud reiterating the four questions the document asked senators to consider: 1) Are there significant flaws in the existing *Statutes* that are corrected by the latest version of ST-83? Are there other flaws that are not addressed by ST-83? 2) What complications or issues may be created or may remain if the latest version of ST-83 goes into effect? 3) Does the Senate have concerns about matters of process and voice in shared governance? 4) What specific comments—on general matters or proposed changes—in ST-83 do you want conveyed to the President for transmission to the Board of Trustees?

Dalpiaz also drew attention to the eight different documents posted with the Senate agenda that provided feedback on ST-83.

Jeffrey Eric Jenkins, Chair of the University Senates Conference (USC), noted that after hearing various and differing concerns from the three universities, the December 2024 deadline to provide feedback was too brief. President Killeen suggested, given the disagreement over the updated document, and comments from the three senates, a rewind of the process sending ST-83 back to USC which will lead to modifications being resubmitted at some later date. There is no deadline pressure and can engage in a full revisiting of the process. Jenkins noted that USC meets at the end of the month and the process moving forward will be discussed.

Several senators expressed concern about the negative consequences that the proposed amendments to the *Statutes* outlined in ST-83 could cause. The Senate engaged in a robust discussion about upholding academic freedom and supported reverting to the current academic freedom language in the *Statutes*. There were concerns about whether the process outlined in the *Statutes* was followed correctly. It was also not clear to some senators what problems the proposed amendments were trying correct.

SP Chair and faculty senator Dalpiaz (ENGR) made a motion to rise and report. The motion was seconded and approved by unanimous consent.
