CC.26.02 Election of the 2025-2026 Senate Executive Committee (SEC) Vice-Chair

### BACKGROUND

The Senate Executive Committee Vice-Chair shall 1) Ensure that Senate committees submit and share annual reports with the Senate; and 2) Perform other duties as the Senate Executive Committee or Senate Executive Committee Chair shall specify. (*Bylaws* Part D.1.b)

The Senate Executive Committee Chair and Vice-Chair shall be elected by and from the membership of the Senate, and who shall be the presiding officers of the Senate Executive Committee. The officers of the Senate Executive Committee shall be elected for terms of one year. (*Bylaws* Part D.1.c-d)

### NOMINATIONS

Nominations for Executive Committee officers shall be made by the incumbent Committee on Committees. Nominations may also be made by others and must be accompanied by consent to serve from the person nominated. Nominations must be received in the Senate Office prior to the date set by the Senate Executive Committee. The nominations will clearly distinguish between Chair and Vice-Chair. The nominator shall provide a brief biographical sketch of each nominee. (*Bylaws* Part A.7.d)

The Senate Committee on Committees nominates the following senator for a one-year term as Vice-Chair of the Senate Executive Committee (SEC) ending in 2026. A statement of interest is included.

# **STATEMENTS OF INTEREST**

## Sara Benson (Associate Professor, LIBR)

In addition, he has regularly served on various shared governance bodies, including Provost's Task Forces, Vice Chancellor reviews, the Senate Executive Committee, and is currently a member of the Joint Advisory Committee on Investment, Licensing, and Naming Rights. He sits on the national AAUP Committee on College and University Governance (Committee T) and serves on the advisory board of Academe.

### Rob Kar (Professor, LAW)

As a professor of law and philosophy, I would be happy to serve as SEC Vice Chair next year if this body believes my experience could be useful. Having led USC as President and Vice President, and as President of this Academic Senate for three years, including during the COVID-19 pandemic, I bring a deep understanding of shared governance, including during periods of crisis. Since then, my roles as President of the local AAUP chapter and head of the philosophy department for three years have strengthened my skills in collaboration and addressing challenges. While I initially stepped back from Senate leadership to support emerging leaders, I recognize that we are at a critical point in the history of higher education and that my experience may be useful for helping traverse today's new challenges.
