**1. CALL TO ORDER**

A meeting of the University of Illinois Urbana-Champaign Senate was called to order at 3:10 pm by Rurik Tywoniw serving as the Presiding Officer of the Senate with William J. Maher serving as Parliamentarian.

**5. SENATE EXECUTIVE COMMITTEE CHAIR'S REMARKS**

Faculty senator (ACES) and Chair of the Senate Executive Committee (SEC), Angela Lyons welcomed senators, thanked members for their service, and expressed appreciation to administrators for their ongoing partnership. She announced that the Annual Faculty Meeting had been rescheduled to the December 8, 2025 Senate meeting to accommodate President Killeen's and Chancellor Isbell's schedules. Chair Lyons noted a new SEC practice inviting Senate committee chairs to present on each of their committees' work, noting that Chair Ralph Mathisen recently provided an overview of key initiatives for the Senate Committee on the Library (LB), including input on the Undergraduate Library renovation, storage planning, budget advocacy, and the spring open forum. She thanked Professor Mathisen, LB members, Dean of Libraries and University Librarian Claire Stewart, and Office of the Senate staff for their important work on LB.

Chair Lyons provided an update on the charge of the Ninth Senate Review Commission (SR9), reminding senators that the *Constitution* mandates a comprehensive review of Senate size, structure, and operations at least every seven years. Following the Senate's decision not to create a separate ad hoc committee on honorary degrees, that topic will be included within SR9's broader review of Senate committees. SEC asked SR9 to issue a report on the honorary degree awards portion of its work by January 23, 2026, with the final report due August 1, 2026. She added that committees may continue reviewing their own processes and that SR9 recommendations are advisory.

Chair Lyons concluded by encouraging a focus on Senate culture and the principles of shared governance. She urged senators to consider "what's going right," to engage constructively, and to approach discussions with trust, openness, and respect, noting the importance of maintaining positive relationships with the administration. She ended her remarks by thanking senators for their service.

In response to concerns about specifying the review of the honorary degree awards process in the SR9 charge, Chair Lyons stated that setting a separate timeline to review the honorary degree awards process was intended to prevent that single issue from dominating the broader review. She again noted that the *Constitution* requires SR9 to review all Senate committees and added that the Eighth Senate Review Commission review focused on the Senate Committee on Educational Policy.

In response to a request for clarification on how the Senate Committee on Honorary Degree (HD) could review its processes if the committee was paused, Chair Lyons clarified that SR9's work is separate from last year's pause on issuing honorary degree awards. HD may continue meeting, reviewing candidates, and evaluating its own procedures. However, the

conferral of honorary degree awards is on hold until a solution is developed to provide candidates with more privacy within the confines of the Illinois Open Meetings Act (OMA). She reiterated that no committees are paused, and the goal is to identify a better process for honoring candidates while also protecting candidate privacy. Senate Parliamentarian H. George Friedman added that the Senate voted down a particular path, but the Senate did not vote down discussing the honorary degree award process. The subject is still open to whatever other motions or procedures are available, including SR9 considering the matter and the honorary degrees committee itself.

In response to a question on whether OMA would allow closed sessions to address confidentiality concerns, Chair Lyons explained that the OMA does not permit a closed session for the discussion of potential honorary degree award recipients. Faculty senator and SEC Vice-Chair Gilmore (LAS) added that OMA exceptions are very narrow, though some matters can be referred to advisory bodies outside of the Senate and OMA, and future recommendations may explore such approaches.

## **6. PROPOSALS**

### **a) EP.26.001, Revise *Student Code* Sections § 3-103, § 3-104, and § 3-201**

On behalf of the Senate Committee on Educational Policy (EP), Chair Nolan Miller introduced and moved approval of EP.26.001. Chair Miller noted that this proposal is a follow-up to last spring's removal of the ABS grade symbol (missing a final examination that was not excused). Two edits to the *Student Code*, 3-103 and 3-104 are purely editorial, noting the prior use of ABS and updating the date when existing ABS grades converted to No Credit (summer 2025). A substantive change to Section 3-201 removes the requirement that students absent from a final exam receive an F, allowing instructors to assign grades consistent with the syllabus and the student's overall performance. No discussion followed and a vote was taken.

By i-clicker and show of hands, and Poll Everywhere, the motion to adopt EP.26.001 was approved with 159 in favor, 1 opposed, and 5 abstentions.

### **b) EP.25.082, Revision to the Language Other Than English (LOTE) Requirement for Online Degree Completion Programs**

On behalf of EP, Chair Nolan Miller introduced EP.25.082 for a first reading. This item proposes to lower the Languages Other Than English (LOTE) requirement from three to two semesters for online degree completion programs. EP Chair Miller explained the rationale, noting challenges adult learners face completing a three-course language sequence online and the limited availability of upper-level online language courses. Senators raised questions regarding difficulty and cost to programs, language-department consultation, potential effects on program equity and rigor, impacts on residential offerings, the value of language study, and concerns about creating a double standard. Chair Miller emphasized that the proposal is narrowly tailored to adult learners in online completion programs, does

not extend to other online degrees, and reflects extensive consultation. Discussion also addressed proficiency definitions, sequencing constraints, and the broader context for online education at Illinois.

As a first reading, no vote was taken.

**c) SP.25.08, Revision to the *Bylaws*, Part D.12 – Committee on General University Policy**

On behalf of the Senate Committee on University Statutes and Senate Procedures (SP), Chair David Dalpiaz introduced and moved approval of SP.25.08. SP Chair Dalpiaz stated that SP.25.08 is a proposal to revise the *Bylaws* for the Senate Committee on General University Policy (GP). The changes clarify and update GP's duties, add responsibility for participating in the Campus Administrative Manual (CAM) review process in collaboration with the Office of the Provost, and charges GP with updating the Faculty Policy Guide. The proposal also expands faculty membership from six to eight and adds the CAM Committee chair (or designee) as an *ex officio* member. Faculty senator Gilmore (LAS) noted that the revision formalizes an informal process for Senate engagement with CAM items that fall within Senate purview.

In response to an inquiry about the possibility of adding an academic professional member, SP Chair Dalpiaz stated he was open to other membership adjustments and suggested it be discussed as part of the broad SR9 review.

By i-clicker and show of hands, and Poll Everywhere, the motion to adopt SP.25.08 was approved with 147 in favor, 0 opposed, and 14 abstentions.

**d) CC.26.20, Election of Members on Standing Committees of the Senate at the October 13, 2025 Senate Meeting**

On behalf of the Senate Committee on Committees (CC), Chair Chaya Sandler presented and moved approval of CC.26.20 to fill current committee vacancies. CC Chair Sandler reviewed CC's process for selecting nominees and noted that the slate of nominees included nominations for the two GP faculty seats that were just created by approval of SP.25.08.

Presiding Officer Tywoniw called for nominations from the floor. Hearing none, floor nominations were declared closed.

By i-clicker and show of hands, and Poll Everywhere, the motion to adopt CC.26.20 was approved with 161 in favor, 0 opposed, and 1 abstention.

- e) **SP.26.03, Proposed Revision to the *Constitution*, Article II, Section 10 and Article V, Sections 1-2, and Revision to the *Bylaws*, Part B.5 (reference to the University of Illinois at Chicago College of Medicine at Urbana-Champaign)**

On behalf of SP, Chair Dalpiaz introduced SP.26.03 for a first reading. SP Chair Dalpiaz explained that this proposed amendment to the *Constitution* and related *Bylaws* is to remove references to the now obsolete University of Illinois Chicago College of Medicine at Urbana-Champaign and to simplify language referring to electorates.

No discussion followed, and as a first reading, no vote was taken.

- f) **SP.25.01, Proposed Revision to the *Statutes*, Article II, Section 3 – Faculty Role in Governance, Article IX, Section 3.c – Appointments, Ranks, and Promotions of the Academic and Administrative Staff, and Article X, Section 1.a(6) – Tenure of Academic Staff**

On behalf of SP, Chair Dalpiaz introduced SP.25.01 for a first reading. SP Chair Dalpiaz noted this proposed revision integrates the term “principal” in the relevant lists of modifiers for the ranks of instructor and lecturer, reorders those lists of modifiers, and truncates the list of examples of modified titles. This proposed revision does not alter the faculty rights or status, which may be addressed in a future proposal.

No discussion followed, and as a first reading, no vote was taken.

- g) **SP.26.02, Proposed Revision to the *Statutes*, Article II, Sections 3a(1) and 3a(2) – Faculty Role in Governance (ST-91)**

On behalf of SP, Chair Dalpiaz introduced SP.26.02 for a first reading. SP Chair Dalpiaz indicated that this proposed revision originated from the University of Illinois Chicago (UIC) Senate. SP.26.02 proposes including certain academic staff that are ineligible for tenure, expanding their governance rights. Although the textual changes are minimal, SP Chair Dalpiaz noted the proposal’s broad policy implications and invited extensive feedback. SP has referred the matter to GP, and further readings may be held before any vote. Faculty senator and SP member Gilmore added that if approved, such a change could require many academic units to revisit their bylaws.

No additional discussion followed, and as a first reading, no vote was taken.

## **7. PUBLIC COMMENT**

## **8. CHANCELLOR’S REMARKS**

John Coleman, Provost and Executive Vice Chancellor for Academic Affairs, delivered remarks in the absence of Chancellor Charles Isbell beginning with the 25th anniversary of the University of Illinois Research Park and its economic and innovation contributions. He then provided federal updates, including the ongoing government shutdown, its likely

effects on research activities, and concern for partner organizations impacted by funding disruptions. He discussed the recent presidential proclamation imposing a possible \$100,000 employer fee on new H-1B visa applications, noting uncertainty about whether universities will be included and advising units to continue normal hiring while International Student and Scholar Services (ISSS) and human resources seek clarification. He also addressed the federal “compact for academic excellence,” stating that Illinois would not participate if invited due to concerns over academic freedom and institutional autonomy.

Coleman announced a new task force to review the university’s Title VI processes, with particular attention to transparency, communication, academic freedom protections, and support for faculty and academic staff named in complaints.

#### **9. QUESTIONS FROM SENATORS**

In response to questions posed, Provost Coleman acknowledged uncertainty about how future H-1B renewals may be handled, confirmed that the campus will examine peer institutions’ models when considering action related to last year’s MADC (Mutual Academic Defense Compact) resolution, and noted ongoing contingency planning regarding potential ICE (U.S. Immigration and Customs Enforcement) or National Guard activity affecting students. He emphasized the broader national risks posed by H-1B restrictions for students, research, and U.S. competitiveness. Regarding Title VI, he stated the task force may consider retroactive application of recommended support measures and will examine concerns about complaints filed by individuals outside the university community.
