MINUTES

1. CALL TO ORDER – ANNUAL MEETING OF THE FACULTY

The Annual Meeting of the Faculty was called to order at 3:12 pm by Angela Lyons, Chair of the Senate Executive Committee. Chair Lyons welcomed everyone, and introduced Timothy Killeen, President of the University of Illinois System and Charles L. Isbell, Jr., Chancellor.

a) PRESIDENT’S REMARKS

President Killeen emphasized the strength and importance of shared governance at the University of Illinois and reaffirmed the central role of faculty in advancing the University’s mission of teaching, research, and service during a challenging national climate for higher education. He highlighted strong systemwide performance, including record fall enrollment exceeding 101,000 students, sustained enrollment growth over the past decade, increased participation of underrepresented minority students, and growth in transfer student enrollment, all achieved without lowering academic standards.

President Killeen reported that the University remains a major economic driver for the state, contributing approximately \$24.9 billion annually and supporting over 270,000 jobs. He noted strong student outcomes, including high graduation rates, lower debt levels, and positive long-term economic and civic impact. Despite grant terminations and federal policy uncertainty, the research enterprise exceeded \$1 billion in expenditures, with continued investment in major initiatives such as quantum research and workforce development programs.

He acknowledged heightened anxiety across higher education and underscored the importance of equity, student support, mental health, and a culture of good faith and kindness. He reported record philanthropic giving of \$657 million, reflecting strong public trust. President Killeen concluded by reaffirming the University’s commitment to academic freedom, access, affordability, diversity, equity, and inclusion, and its resolve to protect the mission while navigating ongoing legal, political, and fiscal challenges.

b) CHANCELLOR’S REMARKS

Chancellor Isbell expressed appreciation for the warm welcome during his first four months and affirmed his commitment to the University of Illinois’ values, emphasizing the responsibility to be “good ancestors” by making decisions that benefit future generations. He highlighted record systemwide and Urbana-Champaign enrollment, including more than 60,000 students on the Urbana-Champaign campus, strong in-state and first-generation student representation, high graduation rates, and continued growth achieved alongside increased selectivity and expanded faculty hiring.

He reported continued excellence in research and global impact, noting highly cited faculty, alumni achievements including a Nobel Prize recipient, and expanding strategic initiatives in Chicago to strengthen collaboration, innovation, and statewide engagement. Chancellor Isbell acknowledged the significant uncertainty facing higher education, including federal funding challenges, but emphasized the University's resilience, collaboration, and transparency in navigating these conditions.

Looking ahead, he called for a forward-looking, inclusive strategic planning process involving the Senate, colleges, and units to clarify priorities, align resources, and ensure institutional agility. He stressed the need to reaffirm higher education as a public good, rebuild public trust, and position Illinois to lead nationally and globally. Chancellor Isbell concluded by expressing confidence in the University's capacity to shape the future of higher education through bold, collaborative action grounded in its mission.

c) OPEN DISCUSSION

Chair Lyons invited questions from the floor.

Faculty senator Andrew Belmont (LAS) raised concerns regarding facilities maintenance in the School of Molecular and Cell Biology, specifically the lack of routine floor cleaning and care over multiple years. He noted that the condition of laboratory floors has resulted in repeated failures of biological and chemical safety inspections, posing contamination risks. The reduced custodial services were attributed to uniform budget cuts across campus buildings. Belmont asked if indirect cost recovery funds are used to support custodial and facilities services, and if not, why are those funds not used to maintain laboratory infrastructure critical to safety and compliance.

Chancellor Isbell responded that he did not have detailed knowledge of this specific situation and committed to following up with the Senior Vice Chancellor for Finance and Administration to review the issue and report back.

Faculty senator Kate Clancy (LAS) thanked the administration for reporting de-identified Title VI complaint information to the U.S. Department of Health and Human Services (HHS) Office for Civil Rights (OCR) and asked about the University's contingency plans should OCR require disclosure of identifiable information in the future.

President Killeen acknowledged the concerns, explained that the University remains legally obligated to comply with federal requirements, and stated that the administration will continue to protect complainants' and respondents' identities to the greatest extent possible while demonstrating institutional compliance. He added that if disclosure becomes unavoidable, affected individuals would be informed.

Multiple student senators, including Hunter Farnham (LAS), Ethan Lopez (LAS), Jonah Brue (LAS), and Kevin Wu (ENGR), along with Student Body President Gabi Del Santo,

expressed concerns regarding changes to the student election system. The students described the dissolution of the Campus Student Election Commission (CSEC) and the creation of the Student Election Board (SEB) without consultation with student government or the Senate. They stated that these actions conflicted with Senate *Bylaws*, reduced student autonomy, and undermined shared governance. The students also raised concerns about revisions to election and referendum rules, potential threats to the recognition and resources of the Illinois Student Council (ISC), and the broader implications for student representation within shared governance structures.

Chancellor Isbell acknowledged the concerns, stated that he was in the process of reviewing the matter, and committed to continued discussions involving Student Affairs, the Office of University Counsel, the Office of the Provost, and shared governance leadership. He emphasized the administration's intent to work collaboratively toward a resolution.

President Killeen commended the students for their engagement and reaffirmed his commitment to working with campus leadership to seek a good-faith outcome consistent with shared governance principles.

d) CLOSING

Chair Lyons thanked President Killeen and Chancellor Isbell for attending and adjourned the Annual Meeting of the Faculty at 4:12 pm.

6. SENATE EXECUTIVE COMMITTEE CHAIR'S REMARKS

Faculty senator (ACES) and Chair of the Senate Executive Committee (SEC), Angela Lyons thanked senators for their continued service and provided updates on recent SEC activities. She reported that SEC heard presentations from the Vice Chancellor for Diversity, Equity,

and Inclusion and the Executive Vice President and Vice President for Academic Affairs; senators were directed to the November 17 SEC meeting minutes for details. She also thanked James Quisenberry and the Senate IT Committee for their shared governance leadership, including work on generative AI governance, the Cybersecurity Improvement Initiative, and major strategic efforts such as Boldly Illinois IT and Illinois Computes.

Chair Lyons highlighted several items for Senate attention. ST-91 (SP.26.02, Proposed Revision to the *Statutes*, Article II, Sections 3a(1) and 3a(2) – Faculty Role in Governance) will be presented for a second reading (no vote) today, with multiple readings anticipated. Senators were encouraged to review the proposal carefully, which was initiated by the University of Illinois Chicago (UIC) Senate, and to submit feedback via the link on the online Senate agenda. She noted that ST-90 (SP.26.01, Proposed Revision to the *Statutes*, Article IX, Section 7a – Sabbatical Leaves and Unpaid Leaves of Absence for Members of the Faculty) will be forthcoming in the spring and urged senators to share both proposals within their units, as they may have significant implications for governance, instructional capacity, and budgeting. She also reminded senators to submit feedback on SC.26.09, Revised Policy on Integrity and Scholarly Activities (USC OT-393), by February 23, 2026, to allow review and response by the SEC.

Chair Lyons concluded by wishing senators a happy holiday season and expressing appreciation for their work and commitment to shared governance, before turning the podium over for technology updates.

Director of the Office of the Senate and Clerk of the Senate, Jenny Roether announced that beginning February 9, 2026, the Senate will transition from iClickers to Poll Everywhere for in-meeting voting. Poll Everywhere, previously used during the pandemic and currently used by remote participants, will be the voting platform going forward for both in-person and remote participation. Senators will be required to create a Poll Everywhere account and may participate in voting via the mobile app, a web browser, or text messaging with a cellular phone.

She noted that detailed instructions and reminders will be distributed by email before and after winter break, as well as prior to the February 9 meeting. While the Office of the Senate cannot assist with third-party password issues, guidance on account setup will be provided. Senators were reminded to bring an electronic device to future meetings to participate in voting.

7. PROPOSALS

a) CC.26.23, Election of Members on Standing Committees of the Senate at the December 8, 2025 Senate Meeting

On behalf of the Senate Committee on Committees (CC), Chair Chaya Sandler presented and moved approval of CC.26.23 to fill current committee vacancies.

Presiding Officer Tywoniw called for nominations from the floor. Faculty senator Somerville (LAS) self-nominated from the floor to serve on the Senate Committee on General University Policy (GP). There were no additional nominations from the floor and nominations were declared closed.

By i-clicker and show of hands, and Poll Everywhere, the motion to adopt CC.26.23 as amended was approved with 152 in favor, 1 opposed, and 3 abstentions.

b) EC.25.03, Adjustment of Values Used in Calculating the Size of Faculty Voting Units for the 2026-2027 Senate Elections

On behalf of the Senate Committee on Elections and Credentials (EC), Chair Matthew Hutchens presented and moved approval of EC.25.03. Hutchens explained that the Senate *Constitution* requires each voting unit to receive one senator, with an apportionment formula used to determine additional representation. The apportionment formula was last adjusted in 2018, and faculty growth of approximately 13% since then would result in about 241 faculty senators under the current formula, exceeding the constitutional goal of approximately 200 senators. The proposed change would adjust the apportionment factor from 5 and 12 to 5 and 13, reducing the projected number of faculty senators to approximately 225. More substantial reductions were considered but deemed imprudent to implement in a single cycle.

By i-clicker and show of hands, and Poll Everywhere, the motion to adopt EC.25.03 as presented was approved with 132 in favor, 12 opposed, and 15 abstentions.

c) EP.26.064-EP.26.067, Proposals to Establish Departments in the Carle Illinois College of Medicine

On behalf of the Senate Committee on Educational Policy (EP), Chair Nolan Miller introduced and moved approval of the following four proposals as a group.

- **EP.26.064, Establish the Department of Obstetrics and Gynecology in the Carle Illinois College of Medicine**
- **EP.26.065, Establish the Department of Psychiatry in the Carle Illinois College of Medicine**
- **EP.26.066, Establish the Department of Family Medicine in the Carle Illinois College of Medicine**

- **EP.26.067, Establish the Department of Internal Medicine Carle Illinois College of Medicine**

Chair Miller noted that these four proposals to establish new departments in the Carle Illinois College of Medicine—Obstetrics and Gynecology, Psychiatry, Family Medicine, and Internal Medicine—as part of an ongoing restructuring of clinical sciences. The changes aim to improve faculty oversight, administrative efficiency, and accreditation alignment. The proposals represent the next phase of a multi-year plan, with timing critical ahead of the 2027 accreditation review. Faculty approved the proposals by an overwhelming vote (115–2), and no objections were raised at the EP public hearing.

Faculty senator Stirek (FAA) asked for clarification on how faculty are defined within the Carle Illinois College of Medicine, particularly regarding individuals with 0% appointments affiliated with the hospital, and whether they are included in faculty governance and evaluation processes. EP Chair Miller noted that the restructuring is intended in part to enable appropriate evaluation of a large faculty body and deferred to the sponsor. Deborah Young clarified that all faculty who teach medical students must be evaluated, that faculty are categorized by level of teaching involvement, and that creating smaller departments is necessary to ensure effective evaluation and oversight of approximately 600 faculty members.

By i-clicker and show of hands, and Poll Everywhere, the motion to adopt EP.26.064, EP.26.065, EP.26.066, and EP.26.067 as a group as presented was approved with 157 in favor, 0 opposed, and 2 abstentions.

d) SP.26.04, Revision to the *Bylaws*, Part B.3 and Part D.6.d – Chair of Committee on Committees

On behalf of the Senate Committee on University Statutes and Senate Procedures (SP), Chair David Dalpiaz introduced and moved approval of SP.26.04. Dalpiaz noted that the proposed *Bylaws* revision would have the Senate elect the Chair of the Committee on Committees (CC) in the same manner as other committee chairs. Currently, CC elects its own chair, which often results in a delay that leaves the SEC without representation from CC at its first meeting. The proposed change would have the CC chair elected by the Senate upon recommendation of the SEC, addressing this timing issue while avoiding self-perpetuation. No discussion.

By i-clicker and show of hands, and Poll Everywhere, the motion to adopt SP.26.04 as presented was approved with 149 in favor, 1 opposed, and 5 abstentions.

e) SP.26.02, Proposed Revision to the *Statutes*, Article II, Sections 3a(1) and 3a(2) – Faculty Role in Governance (ST-91)

On behalf of SP, Chair Dalpiaz introduced SP.26.02 for a second reading without a vote.

Dalpiaz noted that feedback can be submitted directly to him, to the Office of the Senate, or via the link provided on the online Senate agenda.
