## **Program Justification**

---

1. All CHLH and KIN courses have a HK rubric, effective Fall 2024. This revision will reflect those changes.
2. The formatting of the POS, such as footnotes, and additional text (e.g., graduation requirements, university requirements, and general education requirements) has been modified to adhere to the campus General Education Template. CMN 111 and CMN 112 were also removed as specifically recommended courses that would meet the requirements of Composition I.
3. This proposal seeks to revise the core curriculum within the degree. This revision will reduce the courses required of the core. Specifically, four courses were removed from the core: CHLH 101/HK 111, KIN/HK 340, KIN/HK 352, KIN 355/HK 353). One course, HK 160, was added to the core. In addition, this proposal seeks to revise one existing concentration and establish three new concentrations, thereby allowing students more flexibility in creating a curriculum that will best prepare them for their future careers. Currently, we offer one concentration, Teacher Education K-12, which is optional for students. This proposal would require students to select a concentration for graduation (a concentration is not required for admittance). Additionally, the Teacher Education K-12 is being renamed to Teacher Education preK-12.
4. In the program of study table, removed the header of “Anatomy and Physiology” and moved that coursework just under the major requirements. Also removed elective Kinesiology courses requirement and correlate areas requirement.
5. Through this revision, we will also decrease the total hours for the program from 128 to 120. Four courses were removed from the core: CHLH 101/HK 111, KIN/HK 340, KIN/HK 352, KIN 355/HK 353). One course, HK 160, was added to the core. One additional hour of free electives was added to reach 120 hours.
6. Student learning outcomes were added under Program Features, as required for submission within the CIM system.
7. Under Program Features, it was noted that the major will now have transcribed concentrations.

1. The Department of Kinesiology and Community Health became the Department of Health and Kinesiology, effective Fall 2024. The Department previously utilized 5 different rubrics (CHLH, HT, IHLT, KIN, and REHB). In order to promote a more cohesive Department, all courses with a CHLH, IHLT, KIN, and REHB rubric were transitioned to one rubric: HK. As the HT program is a separate graduate program, it was not included in this revision.
2. Per Office of the Provost General Education initiative for transparency and accessibility. The proposed Gen Ed requirements meet the standard established by the University.
3. This revision is warranted based on a) student interest and demand for specific career tracks within the Kinesiology degree, b) the need for more tailored courses to best prepare students for professional degree programs, and c) results from a market survey analysis. The Teacher Education K-12 is being renamed to Teacher Education preK-12 to align with new requirements of the Illinois State Board of Education (ISBE). As our content is appropriate for both elementary and prek students, this change will have no impact on program content.

The Department of Health and Kinesiology formed an Undergraduate Curriculum Review Task Force in August 2021 to review our degrees. Based on a survey sent to current students pursuing the degree in Kinesiology, the majority (64%) were either very satisfied or extremely satisfied by the courses. However, the majority expressed interest in the development of career tracks (94%) or concentrations (78%) within the major. Students commented on the need for more tailored and sequenced courses to best prepare them for the rigors of professional degree programs. Faculty discussions and our work with Eduventures Research (<https://www.encoura.org/eduventures-research/>) also indicated the need to include "Health" in the title of our concentrations to increase enrollments in this increasingly competitive landscape.

According to the Employment Projections 2022-2032 document released in September 2023, "The health care and social assistance sector is projected to not only grow most rapidly of any sector, but it is also projected to create about 45% of all the projected job gains from 2022 to 2032." This is primarily due to the need to provide caregiving and therapy services to the rapidly growing aged population. Physical therapists, occupational therapists, medical doctors, physician assistants, athletic trainers, nurse practitioners, and other health practitioners are required to fill this need. Approximately 74% of current students pursuing the degree in Kinesiology anticipate entering one of these occupations. Although our student success rate for entry into competitive professional programs is very high, some students do not possess the skills or prerequisites or are interested in alternative careers, including careers in fitness, biobehavioral therapy, or physical education teaching/coaching. Therefore, it is essential to provide appropriate career tracks and support for current and incoming students.

Based on this solid justification, we propose to revise the core curriculum and also establish and/or revise the following 4 concentrations within the Kinesiology BS program: 1) Health Sciences, 2) Applied Exercise Science, 3) Biobehavioral Health Science, and 4) Teacher Education preK-12. The first three concentrations listed above will require four complementary, advanced-level courses, along with three advanced-level elective courses that are consistently offered each academic year, for a total of 21 hours that are specific to the concentration. The remaining concentration, Teacher Education preK-12, requires 48 hours of concentration-specific courses. This revision to the Kinesiology degree program was unanimously approved by the faculty in December 2022. While this curriculum revision has taken longer than expected, the faculty continue to be supportive of these curriculum revisions and look forward to implementing them as soon as possible. Faculty members have been kept informed throughout the process, most recently receiving an update at the start of the semester.

4. To make information easier for students to understand, we listed all major requirements in one area, rather than breaking them into different categories. Because students are now required to select a concentration, the elective Kinesiology courses requirement and correlate area requirements are no longer needed. Students will now select a specific concentration and meet the requirements of that concentration.

5. Reducing the total hours required for graduation will make degree attainment more feasible and economical for students.

6. Student learning outcomes were added under Program Features, as required for submission within the CIM system.

7. Because a transcribed concentration is now required for graduation, under Program Features, it was noted that the major will now have transcribed concentrations.

The degree in KIN is the most highly enrolled program in HK, with 115 new freshman and 658 students total in 2023. Our program continues to grow each year and the addition of concentrations will be highly attractive to prospective students and may therefore increase enrollment and degrees awarded. Based on our preliminary surveys, we predict that the majority of students (74%) will choose the Health Sciences concentration, followed by Applied Exercise Science (18%), Biobehavioral Health Science (5%), and then Teacher Education preK-12 (3%). Each student will meet with an assigned advisor twice per year to design a plan of study. During their first year, students will be required to take HK 160 (Foundations and Careers in Kinesiology) as part of the core curriculum, which will assist in choosing a concentration.

Current students will be given the option of completing their current curricular requirements or enrolling in one of the new/revised concentrations and completing the associated requirements.
