Program Justification

1. All CHLH and KIN courses have a HK rubric, effective Fall 2024. This revision will reflect those changes.
2. The formatting of the POS, such as footnotes, and additional text (e.g., graduation requirements, university requirements, and general education requirements) has been modified to adhere to the campus General Education Template. CMN 111 and CMN 112 were also removed as specifically recommended courses that would meet the requirements of Composition I.
3. Program name is being revised from Teacher Education K-12 to Teacher Education preK-12 to adhere to new ISBE requirements.
4. Plan of Study is being revised to update the EPS rubric, which is no longer active, to the EPOL rubric. In addition, the Plan of Study will be revised to add one additional course option (EDUC 202) for students.
5. In the program of study table, removed the header of "Anatomy" and moved that coursework just under the major requirements. Also removed elective Kinesiology courses requirement and correlate areas requirement.
6. This revision will reduce the courses required of the core. Specifically, four courses were removed from the core: CHLH 101/HK 111, KIN/HK 340, KIN/HK 352, KIN 355/HK 353. One course, HK 160, was added to the core. This proposal also seeks to revise the teacher licensure requirements within the concentration. The proposed curriculum removes KIN 401/HK 466 and PSYC 100 or PSYC 103 as requirements, a total of 7 credit hours, and adds one new course (HK 161), which is only 1 credit hour. With this revision, we will also decrease the total hours for the program from 128 to 120.
7. Information regarding GPA requirements was removed from the Program of Study table.
8. Student learning outcomes were added under Program Features, as required for submission within the CIM system.

1. The Department of Kinesiology and Community Health became the Department of Health and Kinesiology, effective Fall 2024. Previously, the Department utilized 5 different rubrics (CHLH, HT, IHLT, KIN, and REHB). In order to promote a more cohesive Department, all courses with a CHLH, IHLT, KIN, and REHB rubric were transitioned to one rubric: HK. For the purposes of this proposal, all KIN rubrics were revised to HK. With this change, some courses have also been renumbered.
2. Per Office of the Provost General Education initiative for transparency and accessibility. The proposed Gen Ed requirements meet the standard established by the University.
3. Illinois State Board of Education (ISBE) has made changes to licensure programs that requires our program be renamed to preK-12. As our content is appropriate for both elementary and preK (pre-kindergarten) students, this change will have no impact on program content.
4. The Plan of Study will be revised to add one additional free elective course for students, as EPOL 201 is no longer offered as frequently as it has been in the past. The reduced course offering makes it challenging for students to enroll in the course, so this proposal will add an additional option (EDUC 202) for students. This course was selected in conjunction with representatives from the Council on Teacher Education, since it will also provide students with the necessary knowledge to meet requirements of the Illinois State Board of Education. Students will now have the option to take EPOL 201 OR EDUC 202 (currently, students who are unable to take EPOL 201 have been receiving waivers to take an alternative course).
5. To make information easier for students to understand, we listed all major requirements in one area, rather than breaking them into different categories. Because students are now required to select a concentration, the elective Kinesiology courses requirement and correlate area requirements are no longer needed. Students will now select a specific concentration and meet the requirements of that concentration.
6. This proposal is part of a larger effort through which we are revising our entire undergraduate curriculum. This revision is warranted based on a) student interest and demand for specific career tracks within the Kinesiology degree, b) the need for more tailored courses to best prepare students for professional degree programs, and c) results from a market survey analysis. The current Physical Education Teacher Education curriculum leaves little room for students to take any free elective courses. This revision will reduce the courses required, thereby allowing students more flexibility in creating a curriculum that will best prepare them for their future careers. Reducing the total hours required for graduation will make degree attainment more feasible and economical for students.

A side-by-side comparison of the program of study is attached, as well as a revised sample sequence. Please note, as outlined in key 94 (related to this proposal), there have also been revisions to the Gen Ed requirements and core courses, which are reflected in the side-by-side comparison.

7. Information regarding GPA requirements has been revised as the Council on Teacher Education is no longer looking separately at UIUC, content and professional GPAs.

8. Student learning outcomes were added under Program Features, as required for submission within the CIM system.
