- Introduction of Cameo Humes who performed the State song: *Illinois*

- Opening Remarks: Chairman Jesse Ruiz

Chairman Ruiz conducted a “general role call” due to late start time of the meeting. Ruiz recognized past Board member David Downey who passed away December 27, 2025. President Killeen also recognized Downey’s long relationship with the University and his positive, powerful, and lasting impact along with his warmth and humanity.

- Introductions: President Killeen introduced Senate Observers and Academic Professional Staff Representative.

- Special Order of Business: Chairman Ruiz noted that this meeting is the Board’s annual meeting during which there will be elections for the Board’s Chair, Executive Committee, Board Officers, and to Delegate Signatures.

Reminder: This process is a combined process of OMA, Board’s Rules, Roberts Rules. Board Chair, Board Secretary, Board Comptroller, University Council, Treasurer (2-year terms) OMA prohibits no secret voting. BOT uses voice vote.

President Killeen's Remarks:

President Killeen noted that he has fully appreciate his time with the University and will continue working in earnest with us throughout the next 18 months. He noted the value of the partnerships he has developed - with the Board of Trustees, with the Chancellors, Provosts, faculty, and staff. He also noted the challenges we are facing – the current budget season as well as challenges across the board for higher ed. President Killeen provided a ppt overview of some of the faculty, instructors, and others across the System noting that we moved from a university that first had 2 instructors and 50 students to now over 7,000 faculty and over 100,000 students.

Killeen emphasized the work that is done beyond teaching and research. Faculty and instructors are also mentors, public speakers and scholars, opinion writers, influencers, working with industry and government to fuel economy. IQMP, DPI, Research Park – their expertise and experience is key attractors for commercial partners. Peer review is fundamental – but a lot of their other work of scholars is underappreciated.

Remarks: Chancellor/Vice President Marie Lynn Miranda - Welcome

Partnerships: Very important! Translate research into real world impact. Inclusive pipelines, drive economic dev. Expand access to research. In 2023, UIC added \$357.7 million income to the Illinois economy. UIDP, C2QA, Argonne, Fermi,

Emerging fields become engines of opportunity for everyone – science, arts, etc. Let's keep building together.

2. Barbara Rambsey, UIC Professor – DEI policies. Retreat from our commitments. Questioning how they have undermined people. MLK - - "rising authoritarianism" where we stand at times of challenging controversy.... We are about a mission we take seriously. Preemptive compliance and capitulation. Have a special meeting on DEI, take into consideration all the letters, reconsider.
3. Illiana Sesilio – Student. Here to share what is happening to the students. Termination of DCEP. Safe space. (Please keep funding...) STEM field faculty are not very thoughtful.
4. Allison Frank – Student. Anti-Semitism. Jewish students are not safe on this campus. Baked into processes, culture, and climate. (Filed 4 different bias reports) First week – Jewish child and family services. University failed to protect me. Zionism – "Hatred is bad, unless it's against Jews."
5. Arwell Wiggins – neuroscience. Don't cancel DuSable Program.
6. Managa Equosho – freshman. DuSable Scholars Program.
7. VJ Shah – Student. we need a mascot at UIUC
8. Tarrell Morton – Assoc. Prof. Stop ending the DeSable Program.
9. Garcia – Professor - Reverse decision about DEI re: scholarships and promoting faculty.
