## Program Justification

1. Eliminate the Joint Program: Community Health, Bachelor of Science & Epidemiology, Master of Public Health

Provide the reasoning for why each change was necessary, using a corresponding numbered item list as it relates to the brief description numbered list above.

1. This elimination is part of a larger initiative to revise the curriculum in Community/Public Health. We are proposing to eliminate our programs in Community Health and eventually replace them with programs in Public Health.

Currently, the Department of Health and Kinesiology offers a B.S. degree in Community Health. While this degree fully prepares students for a successful career in public health, the degree title is not clearly recognized by prospective students and their parents.

Strategic planning and curriculum review exercises in the department conducted from 2020-2022 provide overwhelming support for the establishment of a Public Health major and subsequent deactivation of the Community Health major, based on faculty discussions and survey results from current students and alumni. Additionally, based on conversations with members from the Provost's and Registrar's offices, it was determined that it was better to deactivate our current programs in Community Health and propose new programs in Public Health. There are substantial changes between the two programs, some of which include a new degree title, a new rubric, a new CIP code, revised major requirements, and revised concentrations and concentration requirements.

Because we are deactivating our Community Health undergraduate programs and replacing them with Public Health undergraduate programs, we also need to deactivate the Joint Program: Community Health, Bachelor of Science & Epidemiology, Master of Public Health. At this time, we have already proposed new undergraduate programs in Public Health to replace our undergraduate Community Health programs. Once the new Public Health programs are approved, we will propose a new joint program between Public Health, Bachelor of Science & Epidemiology, Master of Public Health. We anticipate submitting this proposal before the end of the 2025-2026 academic year.

- To be eligible, students have completed their junior year of the BS in Community Health.
- Students must have 3.0 or higher overall GPA to receive admission.
- Students can apply to the program at two different times- the summer before they begin their senior year or at the end of the fall term of their senior year. Application dates vary slightly year to year tied to semester start dates. The upcoming cycle of applications will be due August 1st and December 15th.
- Applications for admission will be reviewed by program staff and an admissions committee, comprised of faculty and staff from the department who teach and advise MPH students.
- Applications are reviewed holistically, looking at GPA and performance in courses, experiential opportunities (work, volunteer experiences, internships), personal statement, and recommendation letters.
- Upon acceptance, students will be admitted to the joint program and meet with their MPH advisor to determine which courses will be taken in their senior year that will apply to both degrees. (During their undergraduate degree, the joint degree students also continue to meet with their undergraduate advisor.)
- Students admitted to the graduate program must maintain an overall 3.0 GPA to remain in good standing.

Over the life of this program, there have been 19 students enrolled in the joint program. At this time, we have four students enrolled in the Joint Program: Community Health, Bachelor of Science & Epidemiology, Master of Public Health, one of whom will graduate this December and three who will graduate in the Fall of 2026. We have also admitted three additional students who will graduate in the Fall of 2027.

This elimination will have minimal impact on enrollment and/or degrees awarded. Students who are currently enrolled in and/or have been admitted to the program will be able to complete their current curricular program in Community Health and the Epidemiology, Master of Public Health, as all required courses will continue to be offered. Additionally, we plan to offer a new joint program in Public Health and Epidemiology, Master of Public Health in the near future.

**Tuition Rate:** The tuition rate for the MPH in Epidemiology is already established at graduate base tuition + \$3,000 for the year. This is a competitive price in line with similar R1 public school tuition in the state (ex: UIC), and significantly lower than private school tuition (ex: Loyola or Northwestern).

**Self-Supporting:** The existing MPH in Epidemiology, as well as the MPH in Public Health, is a self-supporting program, and most MPH degrees offered throughout the US are operated in this manner. This is consistent with most professional and practitioner degrees offered in the country as well. In addition, the MPH in Epidemiology program is being launched with funding from the Investment for Growth program on campus, which specifically targets programs that can offer important benefit to students and show financial sustainability for campus.

The elimination of this program will have no impact on faculty resources. As indicated, we are replacing an existing program, Community Health, with a new program, Public Health. In addition, we will continue to offer the Epidemiology, Master of Public Health. All of the courses included in the proposed Public Health major and the Epidemiology, Master of Public Health are already being taught, so there shouldn't be any changes to class size, teaching loads, and/or student-faculty ratios.
