Proposal to Discontinue the Speech Teaching Option in the Speech Communication Major of the Sciences and Letters Curriculum

BRIEF JUSTIFICATION:

1. <u>Termination of teacher certification in Speech</u>: Teacher certification in Speech will end in Illinois when a new standards-led system takes effect on July 1, 2003.

- Lack of demand: Student demand for the Speech Teaching Option was strong through the 1960s and early 1970s, when it averaged roughly 100 students per year. However, demand declined steadily through the 1980s, stabilizing at a level that is not large enough to support a viable program. From 1991 to 2000, total enrollment in the Speech Teaching Option averaged 3.3 students per year. No students are enrolled in the Option at present. This compares to average enrollments in the Speech Communication major overall of 369 per year in the 1990s, and current enrollment (fall, 2000) of 554.
- 3. <u>Lack of faculty resources to support the program</u>: The need to meet enrollment pressures in high-demand areas and to direct faculty resources to areas of high and emerging disciplinary importance led us to reallocate faculty lines from the speech education area to other areas. As a result, we no longer have faculty members to support instruction in the Speech Teaching Option.
- 4. Poor use of resources: Supervision for students in the Speech Teaching Option is provided by a Ph.D.-level academic professional (appointed as Academic Adviser and Adjunct Assistant Professor) whose primary assignment is as the departmental undergraduate adviser. The time commitment required to supervise the few Speech Teaching students is substantial (including finding student-teaching placements and making repeated on-site observations), taking time that could be spent more effectively on advising our 554 undergraduate majors.
- 5 <u>Availability of alternatives</u>: Teacher preparation programs in speech communication are offered at Illinois State University and Eastern Illinois University, both of which devote substantial faculty resources to the programs.

BUDGETARY AND STAFF IMPLICATIONS:

- a. Additional staff and funds needed: None.
- b. <u>Internal reallocations</u>: Elimination of this program will allow us to reallocate a

portion of an academic professional's time from supervising the Option to undergraduate advising, where it is much needed.

- c. Effect on course enrollments in other departments: None.
- d. Impact on library, computer use, laboratory use, equipment, etc.: None.

GUIDELINES FOR UNDERGRADUATE EDUCATION:

Elimination of a low-demand professional training program that is not viable nor supported by appropriate faculty resources is consistent with the guideline that "professional preparation . . . should be provided for those professions that are of interest to a sizable number of students."
