BRIEF DESCRIPTION:

The LAS major in Latina/Latino Studies provides scholarly grounding in the theoretical and methodological frameworks of this interdisciplinary field whose primary aim is the study of the United States Latina/Latino population. Students must complete a minimum of 34 hours of required courses, which includes a senior thesis, and 6 hours of 200- to 400-level Latina/Latino Studies elective courses. The elective courses are selected from an approved course list maintained by the Latina/Latino Studies Program.

JUSTIFICATION:

In the 14 years that the Latina/Latino Studies Program has been in existence, the Program has consistently attracted more students every year who are interested in a major concentration in Latina/Latino Studies. Some students have shown the initiative to pursue a major in Latina/Latino Studies through the Individual Plan of Study (IPS) Program while others have chosen to simply pursue a Latina/Latino Studies minor (even though they may have been interested in focusing their career toward U.S. Latino populations once they leave the University). In the 2008-2009 academic year we had 21 students graduate with a minor in LLS, which was the largest graduating class ever. As for the IPS major in LLS, prior to the 2008-2009 academic year 9 students received an IPS major in Latina/o Studies and during the 2008-2009 academic year another 4 students graduated with such a major, making for a total of 13 students

who have received an IPS major in LLS since the inception of the Program. It is also of note that during the 2007-2008 academic year, two of the IPS majors in LLS completed a senior thesis and graduated with honors and another IPS major graduated with the same honor in May 2009. Furthermore, approximately 7 students are in different stages of planning for the IPS major in Latina/Latino Studies (from conducting preliminary inquiries about the possibility of pursuing an independent major to submitting their proposal). Clearly, these numbers demonstrate a strong interest in an undergraduate major concentration in Latina/Latino Studies.

In 2008-2009 the Program had 12 core faculty and another 15 faculty affiliates. We believe that the size and varied disciplinary concentrations of our faculty can more than adequately sustain an interdisciplinary undergraduate major program. On average we offer 16 undergraduate courses per semester, and we anticipate that course offerings will grow with the hire of new faculty and the development of new courses. Many peer institutions that offer undergraduate programs in Latina/o Studies offer fewer courses.

We anticipate that many students will opt to pursue a Latina/Latino Studies major when implemented given the number of students over the past few years who have inquired about majoring in LLS but who have chosen not to go further due to the perceived laborious process of the IPS major proposal. Some of these students opted to pursue the Latina/Latino Studies minor instead of the IPS major, which is reflective of the increased numbers of students receiving a Latina/Latino Studies minor.

BUDGETARY AND STAFF IMPLICATIONS:

A. Additional staff and dollars needed:

The Program is in the process of restructuring its administration to better serve students and our curriculum offerings. The Associate Director will become a full time student advisor for the graduate minor and undergraduate minor and major with minor academic programming responsibilities. There will also be a Director of Curriculum and Instruction, which will be filled through a 25% faculty administrative appointment. The faculty director of C&I will be the Chair of the Curriculum Committee with the goal of providing better cohesion in curricular offerings and scheduling.

The Associate Director will also work with faculty advisors, who will be assigned to undergraduate major students according to the students' areas of interest. The senior thesis will be supervised by faculty working independently with students. For the first 5 years of the major we do not anticipate the need for additional teaching assistants.

B. Internal reallocations (e.g., change in class size, teaching loads, student-faculty ratio, etc.):

No internal reallocations are expected.

C. Effect on course enrollment in other units and explanations of discussions with representatives of those departments:

The following departments and programs: African American Studies, American Indian Studies, Anthropology, Asian American Studies, Communication, Curriculum and Instruction, Educational Policy Studies, Gender and Women's Studies, History, Human and Community Development, Human Development and Family Studies, Sociology, and Spanish cross-list courses with Latina/Latino Studies. As our faculty teach courses that are cross-listed and our enrollments increase, the aforementioned units recognize that their major and minor offerings and curricular offerings will be further enhanced.

D. Impact on the University Library:

The undergraduate thesis course will involve in-depth use of library and archival materials. The University's library holdings are adequate for undergraduate research. A letter of support that also addresses the impact has been provided by Paula Kaufman. (See attached.)

E. Impact on computer use, laboratory use, equipment, etc.

There will be no impact on laboratory use and equipment, etc. However, faculty incorporate multimedia in the classroom and use Compass and related technologies for instruction. We still need to avail ourselves of state-of-the-art classrooms for instruction whenever possible.

Students will complete 34 hours of required and elective courses, and a minimum of 18 hours of supporting course work or a minor in an area outside of the major. Students majoring in Latina/Latino Studies receive excellent preparation for graduate study or careers in education, social and welfare policy, counseling, law, public policy, and other fields that address Latino issues.
